Question

FWC - Right of entry forms

Regarding the circumstances of the application by the CFMEU of the right of entry permit for Luke Collier. Mr Enright previously indicated that Dave Hanna from the CFMEU and Mr Collier signed a right of entry permit application but the application failed to disclose that Mr Collier had a criminal history and that the matter had been referred to the AFP for investigation.

o Please provide an update on whether the AFP have finalised their investigation, and whether there has there been an outcome?

o At previous Estimates hearing the Commission stated that the right of entry application form now states it is a criminal offence to lie on the form – has the form been changed to require the applicant to outline what "enquiries" they have undertaken that satisfies them the official is a fit and proper person?

o If not, why not?

o Since the permit for Luke Collier was suspended on application by the FWBC, has the FWC refused or suspended any other permits for failure to disclose information or incorrect information being submitted on permit applications?

o If so, which unions applied for a permit and for whom was the permit sought? o How was it discovered that there had been a failure to disclose or that incorrect information had been submitted?

Answer

- On 24 March 2015, the Fair Work Commission (FWC) formally referred the failure to disclose relevant material in an entry permit application by Mr Luke Collier and Mr David Hanna to the Australian Federal Police (AFP) as a potential contravention of 136.1 of the Commonwealth Criminal Code. On 19 February 2016 the AFP advised that a decision had been taken to finalise the matter and suspend the case with no further action.

- 3. On 18 December 2015 the FWC Rules and Benchbooks Committee met and among other things, agreed that the Form F42 be amended to require an applicant for an entry permit to outline the steps undertaken to ensure the proposed permit holder met the permit qualification matters set out in s 513 of the Fair Work Act 2009. The draft amended Form F42 is currently being considered 'out of session' by the Rules and Benchbooks Committee. The amended form will become operative if approved by the Committee and endorsed by the President of the FWC. The FWC is separately examining recommendations by the Trade Union Royal Commission in its final report published on 31 December 2015 in relation to entry permit applications.

- 4. Since Luke Collier's permit was suspended on 29 January 2015, the FWC has refused or suspended other permits as set out below.
- 5.-6. The following table includes nine (9) people who have either been refused or had their entry permits revoked since 29 January 2015 for reasons (not necessarily the main or only reason) which included the failure to (fully) disclose information or for information lodged being incorrect.
