#### Question

they approved? Can you provide that on notice?

Mr Hart: Yes, we can do that.

### Answer

December 2016 application for additional courses

- In December 2016, the Department of Education and Training invited applications from Listed and not-for-profit providers to include additional courses in the Courses and Caps Determination that were not then on the published eligible course list. These applications were assessed on the basis of evidence of their employer support, employment outcomes and record of studies progression and completion.
- TAFE South Australia (TAFE SA) applied for nine courses, of which six are offered through the Adelaide College of the Arts.
  - Diploma of Arts (Acting) 10259NAT
  - Advanced Diploma of Arts (Acting) 10260NAT
  - Diploma of Jewellery and Object Design MEM50311
  - Advanced Diploma of Jewellery and Object Design MEM60211
  - Diploma of Dance (Elite Performance) CUA50113
  - Advanced Diploma of Dance (Elite Performance) CUA60113.
