### FOI Request

#### Question

Senator CAMERON: Could you provide details of the submissions that were made on this prospective employment? Could you provide all of the submissions that were made for colleges that applied for access to these courses but were denied, and the submissions that were made by the successful ones? I would like to see them, and the differences, and any proper analysis that was made to determine who got in and who was left out. Is that possible?

Dr McEwen: We can take that on notice.

Senator Birmingham: We will take that on notice. We might need to ask the parties for their permission if we are to provide their full submission. I see no particular reason not to, but if you were making an FOI request we would be bound under the *FOI Act* to consult with the parties before releasing it to you. I think it is not unreasonable, given that these are submissions made by third parties, in a commercial sense, for an application, for us to at least engage in a similar level of consultation with them.

#### Answer

- A list of all providers that applied for additional courses, and the courses for which they applied, is contained at **Attachment A** and **Attachment B**.
- Submissions contain details of individuals, including places of employment. As such, the
  Department of Education and Training is presently consulting with providers regarding
  the release of this information.
