Additional funding for students with disability measure

Question

Senator McKIM: Did all jurisdictions receive an increase and none a decrease? Senator Birmingham: None received a decrease, because that was the approach we took that insofar as allocating the additional money—

Senator McKIM: No jurisdiction worse off!

Senator Birmingham: we decided that, given concerns about the robustness of the data available, we wanted to honour our commitment that funding would be informed by this data, but we did not want to unfairly disadvantage a sector if we had qualms about the robustness of it. So it was allocated only on the basis of sectors and jurisdictions where there appeared to be a possible deficit as to whether any states received nothing and, if so, which ones, versus which ones got an increase. Senator McKIM: Could I ask either you or the department for a breakdown, on a jurisdictional basis, of the actual amounts allocated?

Dr Bruniges: I am happy to take it on notice.

CHAIR: And on a system basis.

Senator McKIM: Yes, and a system basis.

Answer

As part of the 2016–17 Budget the Australian Government announced an additional \$118.2 million for schools to support students with disability for the 2016 and 2017 calendar years. This funding is in addition to the students with disability loading provided through the *Australian Education Act 2013*.

The allocation of the additional funding for students with disability measure to the Government and Catholic sectors as announced at the 2016–17 Budget is at **Table 1**.

The Independent sector has been allocated \$22.55 million for the additional funding for students with disability measure for the 2016 and 2017 calendar years. The Department of Education and Training is working with the Independent sector on the allocation of the additional funding for this sector.

States and territories are also receiving an increase of over \$90 million in 2016 and over \$114 million in 2017 through the students with disability loading, as shown at **Table 2**, bringing total Government funding for students with disability to almost \$1.4 billion in 2016 and more than \$1.5 billion in 2017.

The total Commonwealth estimated students with disability loading for the calendar years 2016 and 2017 for each state and territory and sector is at **Table 3**.
