Timber harvest and timber products - funding

Question

What funding has been provided by Federal Government Departments in each financial year from 2012 to 2016 to any external organisations in order to undertake activities relevant to timber harvest and timber products education and/or training programmes, education or awareness raising activities, or teaching resources?

If so, what are the names of recipient organisations, amounts and purpose of the funding including the names or titles of relevant feasibility studies, programmes, events, initiatives, or resources undertaken or proposed.

Answer

The Department of Education and Training provided funding through the National Workforce Development Fund, the Industry Workforce Training measure, the Agriculture in Education initiative and the Commonwealth Grants Scheme.

National Workforce Development Fund and Industry Workforce Training measure Through the National Workforce Development Fund the total funding approved is \$2,560,587, further details of recipients and funding amounts can be found at **Attachment A.** A list of projects funded through the Industry Workforce Training measure can be found at **Attachment B**.

Agriculture in Education

Under the Agriculture in Education initiative, the department provided funding of \$2 million over two years (2013–14 and 2014–15) for online teacher support materials and curriculum resources to help teachers better understand the products and processes associated with food and fibre production and ensure that all students have an opportunity to understand their importance in the Australian economy. Some materials developed as part of this initiative included references to timber production. For example Year 5/6 PDF and video *Exploring sustainable practices in food and fibre production* and a Year 7/8 PDF and video *Investigating key Australian fibre production practices in the cotton, timber and wool sectors*.

The \$2 million funding was provided for all materials developed through the Agriculture in Education initiative (\$1.095 million to the Primary Industries Education Foundation of Australia, \$0.705 million to Food and Agribusiness Solutions formerly Agrifood Skills Australia and \$200,000 to Education Services Australia).

Commonwealth Grants Scheme (CGS).

The department provides funding for units of study classified as forestry studies under cluster 8 of CGS, further information on CGS clusters can be found on the department's website (<u>https://www.education.gov.au/funding-clusters-and-indexed-rates</u>). This is the same rate as other agriculture, environment and related disciplines as well as dentistry, medicine and veterinary studies.

From 2012 to 2015 the following CGS funding was provided for Commonwealth supported students undertaking a forestry studies* unit as part of their course:
