## **Question:**

- 1. Has the department and/or the Minister received submissions or representations from States and Territories concerning the ongoing operational funding for the 38 Children and Family Centres when Element 1 of the National Partnership Agreement on Indigenous Early Childhood Development expires on 30 June 2014? If so, which States and Territories and when was each contact made?
- 2. Has the Minister directed the department to provide advice on funding options for the 38 Children and Family Centres beyond 30 June 2014?
- 3. The 38 Children and Family Centres provide a range of culturally appropriate family services to a number of vulnerable families who may not otherwise be able to access these services. Has the department done any modelling on the impact of mainstream funding through the CCB or CCR on the operation and access to the Children and Family Centres?
