## **Question:**

1. How many amended returns have been submitted following an inquiry by the AEC to the donor or the recipient?

- 2. In the past five years which amended returns have been triggered following an inquiry by the AEC to the donor or the recipient?
- 3. Is this information about an inquiry from the AEC triggering an amended return made public? If so where can this information be found?

#### **Answer:**

- 1. Since 1 July 2013, 62 political parties, associated entities or donors have requested an amendment to their return as a result of an AEC inquiry.
- 2. The AEC is not able to identify which amendments were triggered by an inquiry for the last five years without allocating significant resources to investigate this issue. Attachment A provides a list of returns that have been amended since 1 July 2013 and includes a flag of those returns where an amendment resulted from an AEC inquiry.
