Q1. The were no instances where an ANAO officer accompanied the Minister and/or Parliamentary Secretary on their travel.

- Q2. The ANAO has spent \$436,161 on travel for period . Travel of \$383,082 related to direct audit activities and \$53,079 related to travel associated with audit conferences and meetings, corporate activities and professional development activities. The ANAO's travel management system does not record information to the level of detail requested.
- Q3. The ANAO plans to undertake travel related to direct audit activities as set out in the respective audit work programs. The volume and timing of this travel can vary depending on the audit program and arrangements made with audited entities.

- Q5. Business class travel is permitted for Senior Executive Service staff domestically and all ANAO staff travelling internationally. Staff travel entitlements are established under the ANAO Enterprise Agreement 2011-14 and SES common law contracts. There are no proposed changes to travel entitlements during the life of these agreements.
- Q6. Yes. Employees may request an airline lounge membership where it is justified based on the employees frequency of travel and value for money can be demonstrated. As at November 2013 the ANAO has 57 employees who hold a lounge membership. The annual cost of membership is estimated at \$13,973.
