Dear Senator Heffernan

Having reviewed the Proof Hansard of the Budget Estimates hearing conducted by the Senate Rural and Regional Affairs and Transport Legislation Committee on Tuesday 26 May 2015, I wish to make the following corrections:

#### Item 1:

The first correction relates to my response to a question from the Chair. The relevant dialogue occurs on page 21 of the Proof of Hansard.

**Ms Jakszewicz:** The Natural Heritage Trust funds, as I understand, were reallocated. There were unallocated funds sitting in there that were reallocated to the reef program. Again I am not from a government department; I am from a not-for-profit organisation outside of government. In terms of the Green Army, the cut to the number of projects on the ground was for about three years.

I wish to advise the Committee that I mistakenly advised that the cuts to Green Army projects would be for three years. The correct response should read:

‘In terms of the Green Army, the cut to the number of projects on the ground will be in the third year’

#### Item 2
