**Senator STERLE**: What is the current status of the \$2 billion concessional loan facility?

**Mr Mrdak**: The concessional loan has been essentially contracted or agreed to with New South Wales. That concessional loan will be paid out over the next few years in agreed milestone points. Essentially, the concessional loan has been contracted. I will ask Mr Danks to give you a fuller explanation, if I can.

**Mr Danks**: The first draw-down for the loan will happen before 30 June this year and it will run through to December 2019. It will be drawn down on a pro rata basis with senior debt. So we go in at the same time as the senior banks put money in.

**Senator STERLE**: Are there set payments for set dates?

**Mr Danks**: There are. There is a schedule of about 43 different payments between 30 June this year and 30 December 2019.

**Senator STERLE**: Could you table that for us today? Without me asking you to name them all now, without you taking it away on notice, could that be provided to the secretariat so we can have a look at it?

Mr Danks: I do not have it with me at the moment. I will have to see if I can pull it together.

**Senator RICE**: I wanted to clarify exactly that point on the loan.

**Senator STERLE**: Sure. Can that be done today, Mr Mrdak? Could that be faxed up or something like that—whatever you do?

Mr Mrdak: Yes, we will try and do that.

Senator STERLE: You didn't see my lips move then, Mr Mrdak—see how I did that. With respect to the M80 Ring Road upgrade, also announced on 8 May, have there previously been Commonwealth allocations for the specific work completed?

Mr Mrdak: There was the first stage of M80 project which was agreed in—

Mr Foulds: It commenced from 2009 through to-

Senator STERLE: From 2009, so I work my way through—

Mr Foulds: There was a commitment, I think—I can stand corrected—of \$750 million by the Australian government, which led to a total expenditure of \$1,100 million on the M80.

Senator STERLE: So there was about 400 from the Commonwealth, is that right?

Mr Foulds: No. There was more than 400. Mr Mrdak: We will get you the details. Mr Foulds: We will get you the details shortly.

#### **Answer:**

Under the Infrastructure Investment Programme from 2008-09 to 2013-14, the Australian Government contributed \$864.61 million to upgrade three sections of the M80 Ring Road of approximately 23 kilometres. The total cost to complete these sections was \$1.13 billion.

### Senator Sterle, Glenn asked:

**Mr Mrdak**: There was a commitment of about \$250 million made in 2014 by the government for the remainder of the balance of work to complete the next stage of full work on the M80 process. The offer of the remaining \$350 million is the Australian government's 50 per cent contribution to complete all of the upgrade of the M80 Ring Road.

**Senator STERLE**: As part of the 2009 announcement you were talking about with the M80, the western ring upgrade, am I right to say that in early 2014 nearly \$250 million was cut from the original figure from the Commonwealth for the M80?

**Mr Mrdak**: This Australian government has not made commitments previously. The commitments were made in 2014, and this new commitment to complete the Western Ring Road.

**Senator STERLE**: I understand, but there was a figure—which you are going to find for me—back in 2009 when they first started talking about the M80, or Western Ring Road, and I am led to believe that in 2014 nearly \$250 million was cut from the M80 covering the same work.

Mr Foulds: I would have to get you the precise details on notice.

**Senator STERLE**: But you are not saying that I have got this wrong?

**Mr Foulds**: No, I am not. I can say to you that from 2008-09 to 2013-14 the Australian government did contribute \$864 million, which upgraded 23 kilometres of the M80 at a total cost of \$1.13.

**Senator STERLE:** I just want you to tell me that I am wrong, and that there was not a \$250 million cut. **Mr Foulds**: We will take that on notice.

### **Answer:**

In the 2013-14 Federal Budget, the then Australian Government committed \$525.1 million (50 per cent) to complete the remaining four sections of the M80 Ring Road Upgrade.

In 2014, the former Victorian Government sought to reallocate all but \$76.18 million of this funding to other priority projects in the State, to which the Australian Government agreed.

In May 2015, the Australian Government matched the Victorian Government's \$150 million commitment to upgrade the M80 Ring Road from Sunshine Avenue to the Calder Freeway. This included the \$76.18 million already allocated to the M80 Ring Road Upgrade.

In April 2016, the Australian Government committed an additional \$350 million to complete upgrades of the M80 Ring Road from the Princes Freeway to the Western Highway, from Sydney Road to Edgars Road and from Plenty Road to the Greensborough Highway. This commitment was made on the condition that the Victorian Government also provides a matching contribution.

The Australian Government has also committed \$5 million to undertake planning on the North East Link, which will connect the Eastern Freeway to the M80 Ring Road.

Senator DODSON: What has happened to the \$499 million extra GST money from last year?

**Mr Pittar**: That funding is administered by a separate MOU. That is applied to a range of road projects in Western Australia. I understand that there have been savings in the order of \$26 million according to that project.

Senator STERLE: What project?

**Mr Mrdak**: There are a series of road projects. We will get you the details of those. There are series of road projects in Western Australia which that \$499 million was applied to.

**Senator STERLE**: And that has been spent?

**Mr Mrdak**: That is in the process of being spent, yes. **Senator STERLE**: Yes, you can tell us with that.

Mr Mrdak: Most of those are under construction. We can get you the details of those.

Mr Pittar: I can provide that. Mr Mrdak: We have that now. Senator STERLE: Great.

Mr Pittar: There were savings of \$6 million on the Reid Highway work from that \$499 million and the

Mitchell freeway work of \$20 million.

**Senator DODSON**: Is it possible to table both of those bits of information?

Mr Mrdak: Yes.

**Mr Foulds**: The other projects are the Kwinana Freeway, Roe Highway to Russell Road, and it is a widening southbound; the NorthLink WA Swan Valley bypass—

**Senator STERLE**: Sorry. Can you put some figures around them for us please? You see, as Senator Dodson said, there was \$499 million. So far we have identified a small amount of that.

Mr Foulds: And that money was made available to Western Australia.

**Mr Mrdak**: We will get you the projects and the amounts that are allocated to them. The one Mr Pittar was giving you was the savings to date on a number of them, which have been reinvested in WA.

**Senator STERLE**: Can we have that before we leave today?

Mr Mrdak: Yes we will try and do that so we will not hold you up now.

### **Answer:**

A response to this question was provided on page 117 of Hansard:

**Mr Mrdak**: Senator, while we are waiting for the next item, can I give you the information you asked for on the WA infrastructure package?

**Senator STERLE**: Please.

Mr Mrdak: We got a \$499.1 million payment in 2015. The projects that are being funded with that funding are: the NorthLink WA, Tonkin Highway grade separations, \$84.4 million Australian government money; Swan Valley bypass, \$54.4 million; Kwinana Freeway, Roe Highway to Russel Road, widening southbound, \$23.2 million; Roe Highway—Berkshire Road grade separation, \$8.8 million; Mitchell Freeway, Burns Beach Road to Hester Avenue, \$189.1 million; the Reid Highway-Malaga Drive intersection grade separation, \$61.2 million; Perth traffic congestion management program, \$22.4 million; the Aubin Grove Train Station precinct roadworks, \$20 million; and the Great Eastern Highway Bilgoman Road to Mundaring, \$9.6 million. They are our current spend rates. As Mr Pittar advised earlier, the \$26 million in savings that have been achieved across those projects have been reallocated to the Perth Freight Link project.

Mr Mrdak: I will just get that information for you. I think Mr Foulds gave you a list earlier of rail projects.

**Mr Wood**: If you are referring to the table on Budget Paper No. 1, that table is prepared by the Department of the Treasury. The projects in asset recycling, for example, we do not have the final profile for that as yet; that is a matter for the Department of the Treasury. It could be useful go through the profile for projects that we administer.

**Senator STERLE**: I do not want to waste time. That is fine. I have to ask you guys because you are the main department. If you could tell me how much the public rail spend was, that would be great.

Mr Mrdak: We could give you that on notice.

**Senator STERLE**: Is that another one I can get today before we all run away tonight at 11 o'clock?

**Mr Mrdak**: We will try. We can certainly give you the ones that we administer. As I said, we do not have the profile for the asset recycling.

Senator STERLE: That is fine. If you could tell us what you do now, as a figure.

Mr Mrdak: We will try to do that soon.

**Senator STERLE**: Will you provide that before dinner?

Mr Mrdak: Yes.

**Mr Wood**: Just to be clear, was that across the forwards?

Senator STERLE: Yes, I am talking about 2019-20 because that was in relation to Senator Dodson's earlier

question.

Senator RICE: I am told that the department requested a P90 business case when it was first considering whether it was going to fund WestConnex two years ago. Can you confirm that that was the case? Mr Foulds: The only thing that I would have to check—and I will have to take this on notice—is whether the original business case that was assessed by IA and rated as threshold was P90 or P50.

Senator RICE: I have been told that the department requested a P90 business case two years ago and that in

fact you have not received a P90 business case.

Mr Foulds: I will have to take that on notice. I cannot recall two years ago.

#### **Answer:**

The 2013 WestConnex business case was provided to the Department on 11 September 2013 following its review and endorsement by the NSW Cabinet. The 2013 business case includes capital costs at the P50 level.

The 2015 WestConnex Updated Strategic Business Case was provided to the Department on 17 November 2015 following its review and endorsement by the NSW Cabinet. The updated business case includes capital costs at the P50 level.

The Department has separately been provided with P90 costs for Stages 2 and 3 of WestConnex. The Australian Government grant funding contribution to WestConnex is capped at \$1.5 billion, irrespective of changes to the overall project cost.

The cost probability of a business case does not provide judgement on the quality or confidence of the business case – it relates purely to the costs presented in the business case. A P90 value is an estimate of the project cost based on a 90 per cent probability that the stated cost will not be exceeded. A P50 value is an estimate of the project cost based on a 50 per cent probability that the stated cost will not be exceeded.

Ms Wall: Are you asking for the details of the ones that have been withdrawn?

Senator STERLE: No, of the ones that have been successful.

Ms Wall: Yes. They are available on the web, as well, as we finalise the agreements.

**Senator STERLE**: My final question for this part of the portfolio is: how are we going with the \$400 millionodd break-up you are going to provide to me in relation to our earlier catch-up on GST payments in Perth? **Mr Foulds**: We will have to get that to you after the break.

**Senator STERLE**: So you can? How long will that take? I will give you the secret squirrel: I will have to filibuster before I let you go if I do not get it.

**CHAIR**: Let me give you another tip. We are hoping not to break for dinner. We are hoping to go through and get it out of the road.

#### **Answer:**

A response to this question was provided on page 117 of Hansard:

**Mr Mrdak**: Senator, while we are waiting for the next item, can I give you the information you asked for on the WA infrastructure package?

**Senator STERLE**: Please.

Mr Mrdak: We got a \$499.1 million payment in 2015. The projects that are being funded with that funding are: the NorthLink WA, Tonkin Highway grade separations, \$84.4 million Australian government money; Swan Valley bypass, \$54.4 million; Kwinana Freeway, Roe Highway to Russel Road, widening southbound, \$23.2 million; Roe Highway—Berkshire Road grade separation, \$8.8 million; Mitchell Freeway, Burns Beach Road to Hester Avenue, \$189.1 million; the Reid Highway-Malaga Drive intersection grade separation, \$61.2 million; Perth traffic congestion management program, \$22.4 million; the Aubin Grove Train Station precinct roadworks, \$20 million; and the Great Eastern Highway Bilgoman Road to Mundaring, \$9.6 million. They are our current spend rates. As Mr Pittar advised earlier, the \$26 million in savings that have been achieved across those projects have been reallocated to the Perth Freight Link project.

**Senator STERLE**: Just quickly, what did that all total up to?

Mr Mrdak: It is \$473.1 million.

Senator STERLE: And you are tabling that as well?

Mr Mrdak: Yes, I will table the document.

Senator STERLE: That is fine. Thank you very much. I thank the Department for being so efficient.
