# Senator Gallacher, Alex asked:

**Senator GALLACHER:** Mr Mrdak, can you tell us a bit about some departmental contracts. I refer to the department's list of contracts on foot at 2014-15 and on the department's website. Can you tell us a bit more about the following contracts. Hammond Street Developments is the contractor for vehicle safety standards, vehicle import solution—\$500,101. What was that one about?

**Mr Mrdak:** I believe it is assists us in terms of the new arrangements for the implementation of our redesign of the Australian vehicle import system. Can I take that on notice. I do not have the officers with me who deal with that issue, so if I can through the course of today come back to you in relation to that one.

**Senator GALLACHER:** Okay. Perhaps that is probably going to be the answer for the rest. I have a short sample of these. There is Parsons Brinckerhoff Australia and infrastructure corridor protection. Do you about it know off the top of your head or do you want to take it on notice?

**Mr Mrdak:** That relates to work we have been doing for the Infrastructure Working Group of COAG, which looks at how do we as a nation better protect some of our key corridors. As you know, one of the major issues is that in the past we have not protected long-term corridors adequately, which has added to cost in the future. This is work which, from recollection, involved an examination across the country of practices of corridor preservation, and that has resulted in some work which has gone through to the COAG Infrastructure Working Group. But I can get you some further details—

**Senator GALLACHER:** So it is a high-level look at corridor protection. It is not specific.

**Mr Mrdak:** It is not specific. It particularly looks at what arrangements are in each of the jurisdictions. From recollection—and I will take it on notice—that contract involved looking at what each of the jurisdictions had in place in terms of their land use planning and transport corridor preservation so that we could start to look at what was effectively better practice in the country.

**Senator GALLACHER:** PricewaterhouseCooper's public sector WestConnex financing advice—\$330,000. **Mr Mrdak:** That relates to the concessional loan that we are arranging with the New South Wales government. I will ask Mr Jaggers to give you some details on that one. That piece of work is essentially the Commonwealth' due diligence work in relation to the \$1.5 billion concessional loan.

**Mr Jaggers:** As the secretary said, we have engaged experts on the WestConnex project to do a couple of things. One of them was to look at the fundamentals of the concessional loan. We have also engaged legal expertise. We have engaged traffic modellers as well and, in this case, PricewaterhouseCoopers.

**Senator GALLACHER:** SGS Economics and Planning, Sydney network analysis—\$110,000. What is that about?

**Mr Mrdak:** That relates to a piece of work we are doing to look at long-term capacity of a number of our urban environments, looking at work such as traffic forecasts but also modelling effectively the growth of those major urban areas. It is work which fed into some of the work that Infrastructure Australia did but it is also what we call our network analysis, which we use to prioritise future investment for government in relation to project development.

**Senator GALLACHER:** I have a list of these here, but I will just give you this last one: 'ThinkPlace developed a strategic outlook in Office of Transport Security.' What is that one about?

**Mr Mrdak:** I will just check. I think that work fed into the future outlook document. We did effectively a 25- or 30-year scan of the changing transport security environment, out to about 2025 or beyond, and I think that work involved that process of development and also what that meant in terms of our structure and operation of the organisation to implement that. As you would appreciate, with the traffic growth projections, we have to make fundamental changes to how we operate our security regime just to handle the volumes of growth in our airports and ports in particular. So that work fed into that redesign of our Office of Transport Security.

**Senator GALLACHER:** Thank you. I will put a list of other contracts on notice. Going to road funding, is it the Commonwealth policy to still fund 80 per cent of road projects?

#### **Answer:**

The Vehicle Safety Standards Vehicle Import Solution contract will deliver a replacement IT system to support processing of applications to import road vehicles into Australia.

Mr Mrdak responded to Senator Gallacher's question about a contract on corridor protection by referring to work being undertaken by the Department of Infrastructure and Regional Development, through the Infrastructure Working Group of COAG. The Parson Brinkerhoff contract referred to by Senator Gallacher was another contract on corridor protection undertaken by Infrastructure Australia (IA) to support the work of IA's Australian Infrastructure Audit. This contract was originally signed when IA was part of the Department. The Parsons Brinkerhoff contract transferred to IA after 1 September 2014 when IA became a separate Commonwealth entity.

Senator GALLACHER: In an earlier question we asked about PricewaterhouseCoopers WestConnex financing advice—that contract. So you bought that? Do you have that? Can that be tabled or disclosed?

Mr Mrdak: I will take that on notice to check the details, if you do not mind. Provided it does not—
Senator GALLACHER: That advice underpins all of your decisions in respect of this financing process.

Mr Mrdak: It includes advice on some of the due diligence issues which Mr Danks has talked about. I will take that on notice, if I can.

## **Answer:**

PricewaterhouseCoopers (PwC) were engaged by the Department as part of its due diligence for the WestConnex concessional loan. PwC has provided ongoing advice over the past 18 months on the commercial basis for providing the concessional loan. This ongoing advice, along with ongoing advice from other advisors was considered by government as part of its deliberative process on settling the loan arrangements.

## Senator Bullock, Joe asked:

**Senator BULLOCK:** Do you have a plan for how many of those 53 projects will be completed over the next 12 months?

**Mr Jaggers:** Of those 53 projects, 38 are under construction at the moment. I do not have details about the completion time frames for each of those projects, but usually these projects start and finish within a few months so we are confident that the program is rolling out pretty well.

Senator BULLOCK: So it has been ramped up significantly in this—

**Mr Jaggers:** Those projects have started and I think that is a good sign—38 of the 53. There were two projects withdrawn so there are 51 currently in the program and 38 under construction.

**Senator BULLOCK:** Do you think the 51 will be completed within the financial year?

Mr Jaggers: I might see if Mr Pittar has a better idea of when they might complete.

**Mr Pittars:** I do not have anything better than that, Mr Jaggers.

**Mr Jaggers:** No, Senator, we do not have a completion time frame for each of those projects; but, as I said, I would expect those 38 under construction to complete within the financial year—

**Senator BULLOCK:** As you say, they take only a few months to do.

**Mr Jaggers:** Some of them may take a little bit longer, so it will be case by case. We might be able to come back to you with a bit more detail.

**Senator BULLOCK:** I suppose the only other thing I could ask is whether, in addition to the 38 currently under construction, you expect any of the remaining approved projects to commence construction within the financial year.

**Mr Jaggers:** I am sure that some further projects will commence construction this financial year. I do not have a schedule of when each will start, but we are working with the jurisdictions on each of those projects to make sure that they do happen and that they happen as quickly as possible.

**Senator BULLOCK:** To the extent that you can find additional information, would you be good enough to provide it?

Mr Jaggers: Yes, I am happy to take that on notice.

**Answer:** As at 1 January 2016, 31 projects are under construction, with 27 of those projects scheduled for completion in 2015-16.

**Senator BULLOCK:** No, I took that off. I got the 4.333 by taking the 1.412 off the 5.748, and that gave me 4.333, to which I then added the GST money and still came up short.

**Mr Jaggers:** If you could just give us a moment, I might come back to you on that. I think that the difference in the number that you have calculated there is that 2013-14 year. It is not the extra \$499 million that the government committed to Western Australia, because that did not run through the program; that was a payment from Treasury to the Western Australian Treasury and not part of the Infrastructure Investment Program. But we might just come back with a reconciliation between those two numbers for you.

CHAIR: Can I just seek a clarification of when 'we might come back' means—in the next half-hour?

Mr Jaggers: I can come back after the lunchbreak, if that is okay with you?

# Senator Bullock, Joe asked:

**Senator BULLOCK:** I understand that investments have been made. You have come up with a capacity and a time line for when it might be reached. They are projections. But you must have got your pen and paper out and worked that out. I am asking for your sums and how you worked them out—not the result, but the workings. **Mr Mrdak:** We can certainly give you a summary of the bureau's and the Port of Fremantle's analysis.

#### **Answer:**

The Bureau of Infrastructure, Transport and Regional Economics (BITRE) has conducted various analyses of port throughput. This includes the report 'Containerised and non-containerised trade through Australian ports to 2032–33' available <a href="http://bitre.gov.au/publications/2014/report\_138.aspx">http://bitre.gov.au/publications/2014/report\_138.aspx</a>; the report 'Australian Sea Freight 2012–13' available <a href="https://bitre.gov.au/publications/2014/asf\_2012\_13.aspx">https://bitre.gov.au/publications/2015/water\_056.aspx</a>.

BITRE concludes non-containerised trade through the Port of Fremantle is forecast to grow at an average annual growth rate of 1.1 per cent in the twenty years to 2032–33, and containerised trade at 5.8 per cent. This places Fremantle third of the capital city ports (after Adelaide and Brisbane) for non-containerised freight growth, and second (after Brisbane) for containerised freight growth. Forecast non-containerised throughput in 2032–33 is 31.9 million tonnes, and containerised throughput 2.1 million TEUs (twenty-foot equivalent units).

#### Port capacity

The WA Government expects the current estimated capacity in Twenty Foot Equivalents (TEUs) for the Fremantle Port is 1.2 – 1.4 million TEUs. This was confirmed in the answer to WA Legislative Assembly Question on Notice No. 3799, asked on 18 March 2015 and answered by the Hon Dean Nalder MLA, WA Minister for Transport on 23 April 2015.

#### Timeline for reaching capacity

The Fremantle Port has advised 'Fremantle Port's Inner Harbour container trade is expected to reach optimal capacity within the next 10 to 15 years, with the timing dependent on trade trends and other factors in its 2014 Annual Report.

The WA Government expects the maximum capacity of Fremantle Port will be reached sometime between 2023 and 2036, depending on high and slow annual growth rate estimates. This was confirmed in the answer to WA Legislative Assembly Question on Notice No. 3799, asked on 18 March 2015 and answered by the Hon Dean Nalder MLA, WA Minister for Transport on 23 April 2015.

## Senator Gallacher, Alex asked:

**Senator GALLACHER:** In Queensland, \$186 million less was spent than forecast in 2014. To what projects have these funds been redirected? Will these underspends be allocated or reallocated only within Queensland? Do we know where they have been redirected?

**Mr Mrdak:** I will take that on notice. I think they largely sit within the unallocated contingency, and decisions are yet to be taken on future expenditure of those moneys. Some of them may well be reprofiles on—

**Senator GALLACHER:** Is it possible to get a summation of what has happened there?

Mr Jaggers: Are you particularly interested in 2014-15, or are you talking—

....

**Senator GALLACHER:** This serious of question is probably best taken on notice. In Queensland, \$186 million less was spent than forecast in 2014. The question is: to what projects have these funds been redirected? The supplementary question is: will these underspends be only allocated within Queensland? In WA, \$116 million less was spent than forecast in 2014. To what projects have these funds been redirected? Will they only be allocated within WA?

In South Australia it is \$112 million less than forecast. To what projects are these funds being redirected? Will the underspends be reallocated only within SA? Tasmania has \$41 million. The ACT has \$9 million. So it is the same question with respect to all of those underspends. Can we get a summary of what has been reallocated and what is the position with respect to spending it within that state?

**Mr Mrdak:** Certainly. I think the bulk of those have been reprofiled to further out years because of the spend profile of projects, but if there have been any saves to contingency, we will outline those for you.

...

#### **Answer:**

The underspends Senator Gallacher has referred to in this question have been taken from the Department's response to Question on Notice number 6 from the May 2015 Senate Estimates.

As mentioned by Mr Mrdak during the October estimates (refer page in Hansard 38) underspends in 2014-15 are mainly as a result of reprofiling of projects. This reprofiling is evident by the Variance column (last column) for the project over the life of the programme 2013-14 to 2019-20 Onwards.

#### Oueensland \$186.16 million

The major underspends in 2014-15 included:

- O Queensland Contingencies \$186.50 million. Funding was allocated to other projects in the Queensland Programme of Work, re-profiled to out years and offset programmes within the Infrastructure and Regional Development Programme (\$74 million). Net decrease in the Queensland Contingencies over the life of the programme 2013-14 to 2019-20 Onwards is \$40.73 million.
- o Bruce Highway project \$143.14 million re-profiled to out years.

Queensland had a net decrease of \$44.88 million over the life of the programme 2013-14 to 2019-20 Onwards in the 2015-16 Budget. New funding of \$49.30 million was provided for National Highway Upgrade Programme projects.

#### - Western Australia \$116.38 million

The major underspends in 2014-15 included:

- o Perth Freight Link project \$74 million re-profiled to out years;
- o Great Northern Highway Muchea to Wubin project \$37.30 million re-profiled to out years; and

o North West Coastal Highway - Minilya to Barradale project - \$24.66 million re-profiled to out years and \$1.28 million allocated to Outback Way.

Western Australia had a net increase of \$31.8 million over the life of the programme 2013-14 to 2019-20 Onwards in the 2015-16 Budget. The major contributing factor for this increase was new funding of \$32.20 million for National Highway Upgrade Programme projects.

#### South Australia \$112.21 million

The major underspends in 2014-15 included:

- o North-South Corridor Adelaide project (Investment) -\$53.20 million re-profiled to out years; and
- o North-South Corridor Adelaide project (Asset Recycling Fund) -\$38 million re-profiled to out years.

South Australia had a net increase of \$21.82 million over the life of the programme 2013-14 to 2019-20 Onwards in the 2015-16 Budget. The major contributing factor for this increase was new funding of \$19.89 million for National Highway Upgrade Programme projects.

#### - Tasmania \$40.63 million

The major underspends in 2014-15 included:

- o Freight Rail Revitalisation Network project -\$22.50 million reduced from 2014-15 financial year and total project funding by \$59.80 million.
  - Funding for the Tasmanian Freight Rail Revitalisation project was negotiated on a matching basis. Should Tasmania bring forward a proposal for further capital works on the rail network supported by a matched funding commitment, a further \$59.8 million will be made available through future Budget process.
- o Tasman Highway project \$8.99 million re-profiled to out years.
- o Midland Highway project \$4.46 million re-profiled to out years.

Tasmania had a net decrease of \$22.39 million over the life of the programme 2013-14 to 2019-20 Onwards in the 2015-16 Budget. New funding of \$7.68 million was provided for the National Highway Upgrade Programme project – Bass Highway Duplication between Birralee Road and Exton.

# - Australian Capital Territory \$9.15 million

The major underspend in 2014-15 was Majura Parkway, \$6.92 million this funding was reprofiled to 2015-16.

The Australian Capital Territory had a net increase of \$3.34 million over the life of the programme 2013-14 to 2019-20 Onwards in the 2015-16 Budget. The major contributing factor for this increase was new funding of \$3.20 million for a National Highway Upgrade Programme project.

# Senator Ludlam, Scott asked:

Senator LUDLAM: Okay, if that work has been done, if you are able to do that. It is probably a bit frustrating for you guys. If this material were in the public domain I would not have to quiz you about this kind of line item but we are working a bit in the dark, unfortunately. So if you are able to disaggregate for us, what I am most interested in is three categories: heavy freight that is tolled, light freight that is not tolled and then the balance presumably would be passenger traffic. I am interested to know, as Senator Rice was on the East West Link case, what are the model traffic time savings for each of those three classes of vehicle when you are calculating the benefit? I am really interested in that.

How do you model and what assumptions do you use for the fact that, in five years when this thing is a colossal traffic jam, as everywhere else is, those travel time benefits have evaporated, congestion is rising and eventually swamping the benefits that supposedly justify the project in the first place? How do you do that?

**Mr Pittar:** The project has been modelled over 30-year time frames based on projected traffic growth and so on. So the expectation is that the benefits of the project would be of long-term duration.

Senator LUDLAM: That did not quite answer my question. Do you incorporate, when you are calculating these things, rising traffic congestion that gradually eats away at and eventually eliminates the travel time savings? Mr Jaggers: We do. We also look at the base or the do-nothing case as well, which also has models in congestion. So you are comparing it against not having the project versus having the project. So the congestion obviously does increase on the new project over time. That is the case with every project as growth occurs. So we do have some details. I might see if we can take that on notice and get you the details.

# **Answer:**

The traffic modelling takes into account the impact of projected increases in traffic volumes on travel times. The traffic modelling for Perth Freight Link found no reduction in benefits over the 30 year evaluation period.

**Mr Jaggers:** I will get the details for you, but the Australian government commitment to Tas freight rail was in the order of \$119 million. It was to be matched by Tasmania and the Tasmanian government returned with a smaller scope of \$119 million for the project, so the project that is now proceeding is of the order of \$119 million, of which the Australian government is contributing half.

#### **Answer:**

The Australian Government's current commitment for the Tasmanian Rail Revitalisation project is \$119.6 million. The Australian Government's original commitment was \$179.4 million. \$30 million was transferred to the Tasmanian Irrigation Tranche II project and \$29.8 million was retained in the Tasmanian contingency within the Infrastructure Investment Programme.

Funding for this project was negotiated on a matching basis and a contribution of \$59.8 million each was agreed by both Tasmania and the Commonwealth.

Should Tasmania bring forward a proposal for further capital works on the rail network supported by a matched funding commitment, a further \$59.8 million will be made available through future Budget processes.

**Senator GALLACHER:** Six to one. Is it possible to get a list of the successful projects, the ones that are committed and contracted?

**Mr McCormick:** We can take that on notice. On the website we have listed the 51 successful projects, and we can identify which ones have been contracted. By the time we do that on notice obviously there will have been more contracted.

**Senator GALLACHER:** What is the total funding for the projects that have signed agreements with the department? I think you said it was 22, was it?

Mr McCormick: Of the 22 that are under negotiation, nine have actually been contracted. So, that is the 31—

**Senator GALLACHER:** What about the ones that have signed agreements?

Mr McCormick: I am sorry, I do not have that. I can add that up for you.

**Senator GALLACHER:** So, there is \$200 million in the pool. There are 51 projects. Did you say 22 had signed agreements?

**Mr McCormick:** Nine had signed agreements and 22 are currently negotiating. They are nearly ready to sign. **Senator GALLACHER:** Do we know how many the nine have got?

**Mr McCormick:** I have a complete list here. I do not have that breakdown, though, into those groups. I can provide that on notice. Of the 51 successfuls, they are being funded for \$212.3 million and total project value of \$642 million.

**Senator GALLACHER:** Perhaps on notice if you could give us the total funding amount for the projects that have signed agreements.

Mr McCormick: Certainly.

Senator GALLACHER: And a list of those projects.

Mr McCormick: As required, we list them on our website as well as soon as the funding agreement is

executed.

**Senator GALLACHER:** Do you have a ballpark figure for the total funding for projects that do not have signed agreements?

Mr McCormick: That will be the difference. I am sorry that I cannot—

**Senator GALLACHER:** They do follow, rationally. It is fine for you to say to go to the website and have a look, but that is why we have estimates; so that we can ask you.

Mr McCormick: Certainly. I can provide that.

**Senator GALLACHER:** I am sure we could get a staff member to go trawling through all the websites and collating spreadsheets, but we may well end up in the same position that we were in a minute ago, where the information on the websites is so out of whack that we end up with a disjointed view of the world. That is why we are asking you. If you could give us a spreadsheet—51 projects, \$212 million. That is excellent. Nine contracted—excellent. If we could get a breakdown of that \$212 million for where they all are that would be really superb.

Mr McCormick: I can give you the nine individual ones now, if you like.

**Senator GALLACHER:** I would prefer if we got all of the information. On notice if you could have them total that up.

Mr Mrdak: We will do that.

### Senator Peris, Nova asked:

**Mr Mrdak:** In the case of the ACT and New South Wales, they submitted a number of assets they proposed as part of their asset sales. They identified projects from which those proceeds would be spent which were an agreed list of infrastructure investment. The program provides that the proceeds of sale have to be reinvested in new productive infrastructure over and above what would otherwise have been delivered. A funding agreement was reached with the respective treasurers to do that.

**Senator GALLACHER:** So, 100 per cent of the sale proceeds?

Mr Mrdak: Have to be reinvested.

**Senator GALLACHER:** One hundred per cent?

**Mr Mrdak:** That is right.

**Senator GALLACHER:** So, the whole proceeds from the port?

**Mr Mrdak:** Into new productive infrastructure or debt retirement which otherwise enables infrastructure investments. I can get the details for you. As I said, we are not the agency which administers this program, but they are the basic parameters under which it operates.

#### **Answer:**

The Asset Recycling Initiative provides incentive payments to states and territories that sell assets and reinvest the sale proceeds to fund economic infrastructure.

In order to be eligible for incentive payments under the Initiative, the state or territory government (the State) must:

- divest a significant interest in an asset through a sale or by unlocking funding through some other means (such as through a long-term lease). The decision to divest must have been significantly influenced by the Initiative; and
- reinvest the proceeds of the asset divestment as well as the incentive payment in infrastructure projects that: demonstrate a clear net positive benefit; enhance the long-term productive capacity of the economy; and, where possible, provide for enhanced private sector involvement.

The assets to be sold and new projects for investment are formally agreed between the Commonwealth and relevant State, and are included as a Schedule to the *National Partnership Agreement on Asset Recycling*. States and territories have until 30 June 2016 to reach an agreement with the Commonwealth on the sale of assets and the infrastructure projects that would be eligible under the Initiative.

To be eligible, the assets must be sold and construction must commence no later than 30 June 2019.

The Commonwealth incentive payment equals 15 per cent of the proceeds of the asset sales that are reinvested into the agreed infrastructure projects.

#### **Answer:**

To be eligible for funding under the Asset Recycling Initiative, States and territories must sell assets and reinvest the sale proceeds in agreed productivity-enhancing infrastructure projects.

The projects must meet the minimum eligibility criteria, as assessed by the Treasurer with advice from relevant portfolio Ministers, including the Minister for Infrastructure and Regional Development. In proposing projects for funding through the Initiative, jurisdictions must provide information demonstrating that each project:

- provides a clear net positive benefit;
- enhances the long term productivity enhancing capacity of the economy; and
- where possible, provides for enhanced private sector involvement in both the funding and financing of the infrastructure.

The Commonwealth may also consider projects which meet the long-term economic infrastructure priorities in regional economies.

Treasury advise that, as at 30 October 2015 the Northern Territory Government has not put forward a formal proposal to Treasury for consideration for inclusion the Asset Recycling Initiative. Formal proposals will be assessed against the eligibility criteria once received.

Mr Mrdak: I do not believe so through this portfolio.

**CHAIR:** You can take this on notice: has the Commonwealth government put funds in? It bemuses me that, according to their own staff and data that I have here—and I am not too sure what is described as a business partner—the business partners of the Landbridge Group that is buying the port, which I presume means financiers and whatever, is a company called CNOOC and China National Petroleum, which is a large petroleum company up there who have been done over for corruption and so on under the recent crackdown. Blokes have gone to jail and so on. They are fully sovereign owned. I just wonder whether we are awake to all that sort of stuff. It bemuses me that we would develop infrastructure and then cash it to another country, given what is going on in the South China Sea. You actually say, 'Well, come down here and we'll sell you the port.'

**Mr Mrdak:** Treasury have made the payment under that national partnership agreement. My understanding is that that funding is now being managed by the state of Western Australia.

Senator CONROY: Yes, but it has to be acquitted. They have got to say: this is what we did with it.

Mr Mrdak: I will find out the details of the acquittal process.

#### **Answer:**

Treasury has provided the following information on its acquittal process:

Under the Intergovernmental Agreement on Federal Financial Relations (IGA), the Commonwealth provides National Partnership (NP) payments to the States and Territories to support the delivery of specified outputs or projects, to facilitate reforms, and to reward those jurisdictions that deliver on nationally significant reforms.

Paragraph D37 of the IGA states that each State and Territory Treasurer must provide a report to the Standing Council for Federal Financial Relations, now known as the Council on Federal Financial Relations (CFFR) within six months of the end of every financial year, reporting:

- total expenditure under the relevant National Partnership agreement;
- expenditure of both Commonwealth project and facilitation funding; and
- State and Territory co-contributions, where required by the National Partnership agreement.

This information is tracked for all NP payments, across all portfolios. It is also tracked across multiple financial years, so the Commonwealth is able to see in what year the funds are expended.

For the 2014-15 acquittal process, Western Australia has been asked to report the above information for the 2014-15 financial year. Western Australia will continue to be asked to acquit the funds until the entirety of the funding has been expended.

In addition, the National Partnership on Infrastructure Projects in Western Australia requires Western Australia to meet various reporting requirements for each of the specified projects. Below is an extract of the reporting clauses included in the Agreement:

- 20. For the Tonkin Highway, Swan Valley Bypass, Kwinana Freeway and Roe Highway projects, Western Australia will report in accordance with the requirements of the National Partnership on Land Transport Infrastructure Projects.
- 21. For the Mitchell Freeway, Reid Highway, Aubin Grove and Great Eastern Highway projects and the Traffic Congestion Management Programme, Western Australia will provide the Commonwealth Departments of the Treasury, and Infrastructure and Regional Development with:
  - (a) the necessary assurances required under clause 25 of this Agreement;
  - (b) an Annual Financial Statement and Audit Report; and
  - (c) a post-completion report within twelve months of completion of each project.

- 22. Annual Financial Statements and Audit Reports will be consistent with those submitted to the Department of Infrastructure and Regional Development under the National Partnership on Land Transport Infrastructure Projects. Post-completion reports will be consistent with those submitted to the Department of Infrastructure and Regional Development under the National Partnership on Land Transport Infrastructure Projects during the post-completion phase of the project.
- 23. The Commonwealth will provide a total financial contribution to the State of \$499.1 million in respect of this Agreement on a one-off basis for the projects specified in clause 10. All payments are exclusive of GST.
- 24. Commonwealth funding is conditional on:
  - (a) in accordance with the Fair Work (Building Industry) Act 2012, financial contributions to a building project or projects as defined under the Fair Work (Building Industry Accreditation Scheme) Regulations 2005, only being made where a builder or builders accredited under the Australian Government Building and Construction OccupationalWHS Accreditation Scheme is contracted; and
  - (b) for projects that do not have a contract in place at the time of signing this Agreement, compliance with the Building Code 2013.
- 25. Accordingly, Western Australia is responsible for ensuring that:
  - (a) only a builder or builders accredited under the Australian Government Building and Construction Occupational WHS Accreditation Scheme is contracted, and providing the necessary assurances to the Commonwealth; and
  - (b) for projects that do not have a contract in place at the time of signing this Agreement, compliance with the Building Code 2013 is made a condition of tender for all contractors and subcontractors who tender for the work, and providing necessary assurances to the Commonwealth.

However, councils remain able to submit proposals after this date providing completion occurs prior to 30 June 2019.

Declared Councils that can receive funding under the DCP are those specified by the Minister for Infrastructure and Regional Development and the Minister for Agriculture and Water Resources at their discretion. The DCP does not create an entitlement for all drought-affected Councils to receive funding under the programme.
