- Agencies that **are not required to appear** include Aboriginal Hostels Limited, Anindilyakwa Land Council, Central Land Council, Indigenous Land Corporation, Northern Land Council, Tiwi Land Council and the Wreck Bay Aboriginal Community Council.
- The Torres Strait Regional Authority will be called to appear at a later time. It is likely that the hearing will be held on 22 March 2012.
- General policy and implementation matters relating to the Basics Card, Income Management, and links between Aboriginal Medical Services and Medicare Locals will be considered by the Community Affairs Committee during FaHCSIA and Human Services estimates hearings on Thursday 16 February 2012. Matters particularly related to indigenous communities will be considered at the cross-portfolio hearing.
- Indigenous education (including SEAM) and housing for teachers will be considered by the Education, Employment and Workplace Relations Committee during DEEWR's estimates hearings.
- Any Indigenous law and justice matters, including Native Title, night patrols, and alcohol management would be considered by the Legal and Constitutional Affairs Committee during estimates for the Attorney-General's portfolio.
