In answer to questions W799-07 in November 2006 you said that the Australian Indigenous Leadership Centre was selected to run CDEP Management courses for Indigenous leaders based on a review of potential providers, and that AILC met criteria set by the Department. Can you provide a list of these criteria?

#### **Answer:**

Potential organisations identified to deliver the leadership pilot were assessed on their ability to deliver accredited Indigenous leadership training on a national basis with consideration given to organisations that had a proven track record of providing leadership training to Indigenous Australians. Consideration was also given to:

- The ability to provide the training in a culturally sensitive manner;
- The ability to deliver the training within the required timeframe; and
- Value for money.

The Australian Indigenous Leadership Centre was considered the most suitable provider to meet the criteria.

Could you clarify this please as I can find no such community in Alice Springs - there is on DEWR website list of CDEP organisations such an organisation but it is in New South Wales, NOT Alice Springs.

#### **Answer:**

With reference to question W802-07 the response should have read the pilot programme consisted of two residential components. The first was held at Coffs Harbour at the Yarrawarra Aboriginal Community. The second residential was at Alice Springs at the Alice Springs Resort.

#### **Answer:**

CDEP contract managers actively work with organisations to develop and implement organisation capacity building plans, of which governance is an element. Assistance provided may include additional funding to undertake training or engage professional assistance, and the appointment of funds controllers and project managers as required. As part of CDEP's ongoing contract management, issues relating to governance, management and contractual compliance are raised with organisations as they arise and strategies developed with each organisation to improve performance.

Caveats are put in place to ensure that the Commonwealth's equitable interest is protected. It would only be in circumstances that the Commonwealth approved the sale or transfer of an asset that the caveat would be lifted.

The total value of assets held by CDEP organisations facing closure is held by organisations. The requested information is not readily ascertainable, and to provide the requested answer would require an unreasonable diversion of departmental/portfolio resources.

#### **Answer:**

On 7 September 2007, the Indigenous Economic Development Trust was established to assist with the long term management of Australian Government funded assets.

Indigenous Business Australia has been appointed the sole trustee and the beneficiaries are Indigenous Australians and Indigenous Bodies. The purposes of the Trust are:

- to assist and enhance Indigenous Australian self-management and economic self-sufficiency; and
- to advance the commercial and economic interests of Indigenous Australians by accumulating and using substantial capital assets for the benefit of Indigenous Australians

#### **Answer:**

Breach is a term used to describe failure of contracted CDEP providers to meet contractual requirements and is not used in the context of participant eligibility. CDEP participants are required to meet eligibility requirements and are exited from CDEP if they fail to do so.

These modifications were made by Indigenous Business Australia under our contract with the Department of Families, Housing, Community Services and Indigenous Affairs.

- IBA believes the House to be uninhabitable for any reason.

Depending on the nature and severity of the default, IBA would work with the tenants to resolve the issues, in a like manner to public housing arrangements.

One of the stores under management was evaluated in a Market Basket Survey (survey) conducted by the Northern Territory Government. The store is located 185km on gravel road from the Stuart Highway and 31/2 hours from Tennant Creek. The survey compared this store with the costs and availability of the range of goods in the basket. The total basket costs for this store was \$619 compared with the Tennant Creek Supermarket (\$512). This store also had the greatest range of fruit (12) and vegetables (19) available for sale.

The employers for these positions are Budget Based Funded child care services in the Northern Territory funded by the Department of Education, Employment and Workplace Relations. Award wages are paid, calculated in accordance with the *Children's Services* (Northern Territory) Award 200, based on experience and qualifications of the employee and the number of hours worked.

This measure normalises all CDEP workers employed in essential child care positions in Budget Based Funded child care services
