#### Question

#### Establishment of a minimum of 35 Integrated Children and Family Centres

In relation to the initiative to set up over 6 years 34 early childhood education centres, as foreshadowed in the Prime Minister's Apology speech:

- How many sites for these 34 centres have been chosen so far?
- What are their locations?
- What is the timetable for choosing any of the 34 sites not chosen already?
- Has any construction work commenced yet?
- What is the timetable for construction of the centres?
- How many teachers have been already engaged to work at the centres?
- How many teachers have been already engaged to provide pre-literacy and prenumeracy teaching at the centres?
- What is the timetable for employing all the staff, including teachers, not already engaged?
- How will educational outcomes at the centres be monitored?

#### **Answer**

Four locations for Children and Family Centres have already been identified.

The locations are Maningrida and Yuendumu in the Northern Territory, Halls Creek in Western Australia and Mt Isa in Queensland. The remainder of centres have been allocated on a jurisdictional basis as indicated in the following table:

The actual locations of the remaining 31 centres have not been finalised as jurisdictions are still undertaking their planning and consultation processes.

Construction has not commenced. Not all Centres will involve construction; some may involve refurbishment, or the integration of services into existing facilities. A timetable for construction work is not yet available, given that State and Territory governments are still finalising their own jurisdictional timetables.

As Centres are not yet operational, no staff have been engaged; this will be driven by the centre opening timetable.

The educational and health outcomes will be evaluated through a comprehensive national evaluation over the life of the National Partnership.

Senator Mason asked on Friday 24 October 2008, EEWR Hansard page 56.

#### Question

In February, the Prime Minister made his apology speech. He made the commitment that, over the next five years, every Indigenous four-year-old in remote communities will be enrolled in and attending a proper early childhood education centre or opportunity, and engaged in proper pre-literacy and pre-numeracy programs. I have asked some questions about this in the past, and it was fair enough that not much time had elapsed since that speech. I was just wondering whether you had anything to report, particularly in relation to facilities and, secondly, in relation to appropriate teachers. How are we going?

#### **Answer**

- COAG has asked the Productivity Agenda Working Group to develop early childhood education and care reform proposals.
- Indigenous children living in remote communities have been identified as a specific focus
  for universal access to early childhood education. As part of Closing the Gap between
  Indigenous and non-Indigenous Australians, the Council of Australian Governments'
  (COAG) has agreed a target to ensure all indigenous four year olds in remote
  communities have access to early childhood education within five years.
- At its October meeting COAG signed off its first National Partnership (NP) covering Indigenous Early Childhood Development. This NP comprises of \$564 million of joint funding over six years to address the needs of Indigenous children in their early years. As part of the initiative, 35 children and family centres will be established in Indigenous communities across Australia to deliver integrated services that offer early learning, child care and family support programs.
- At its November 2008 meeting, COAG leaders signed the Early Childhood Education NP. This Agreement commits the Australian Government and all states and territory governments to achieving universal access to quality early childhood education by 2013.
- To support this goal, the Australian Government is providing under the NP, a further \$970 million over five years, starting with \$40 million in 2008–2009 and building to \$450 million in 2012–13. This funding is to support specific strategies and implementation plans in each state and territory to improve the accessibility, quality and hours of early childhood education, with improving access for eligible children in remote Indigenous communities, a key priority.
- COAG will hold a dedicated meeting in 2009 to agree to a national strategy for achieving its 'Closing the Gap' targets.

- In the 2007–08 Additional Estimates, \$10 million was appropriated for projects to enhance access to early childhood education for Indigenous children and children from low socioeconomic communities. - The Government has committed to reducing by up to half the HECS-HELP debt of early childhood teachers who work in Indigenous communities, regional and remote areas and areas of high disadvantage.

#### Question

Accelerated literacy program

"Senator ADAMS—Have they had to employ any extra teachers to carry out this program?

Ms Smith—It would be my understanding they have, Senator.

Senator ADAMS—And they have been able to accommodate all the schools that are involved?

Ms Smith—I am not sure that they have been able to recruit in every case that they have sought to, but I do not have precise numbers for you.

Senator ADAMS—Would you be able to take that on notice and let us know just where that program is?

Ms Smith - Certainly."

#### **Answer**

Northern Territory Education providers have advised that they are not specifically recruiting teachers for their Accelerated Literacy programs, at this time. They use Teachers of exemplary practice on a short-term basis to provide classroom coaching and mentoring.

The Accelerating Literacy measure of the Northern Territory Emergency Response is managed as an integrated package with the Quality Teaching Package in partnership with the Northern Territory education providers.

The Northern Territory Department of Education and Training has established three specialist teams to work with 35 targeted remote schools. Two 'Remote Schools Improvement Strategy teams' are based in Darwin and a 'Strengthening Classroom Practices Project team' is based in Alice Springs.

Northern Territory Catholic Education Office has established their 'Practitioners in Residence' team and is targeting ten non-government remote schools.

#### **Question 002**

(In relation to the Northern Territory Emergency Response, in the 12 months since the beginning of the initiative what educational outcomes have been achieved by the Indigenous school-age children?)

How do these outcomes compare to outcomes achieved in the 12 months before the Emergency Response?

#### Answer

Results from the 2008 National Assessment Program in Literacy and Numeracy (NAPLAN) will provide common information about student performance to parents and teachers across Australia - including Indigenous students in the Northern Territory.

Changes in student achievement will be able to be monitored over subsequent years on this basis to show the impact of the Northern Territory Emergency Response and other school initiatives taken by the Northern Territory and Commonwealth Governments.

Due to changes to the national literacy and numeracy testing regimes in 2008, it is not possible to compare 2007 and 2008 educational outcomes on this basis.

#### **Answer**

Senator Boyce asked on 24 October 2008, in Hansard on page 66.

#### Question

Does the department measure results for Structured Training and Employment Projects (STEP) under the Indigenous Employment Program more than three months after completion? If so, what are the results?

#### **Answer**

The department collects available data on the outcomes of job seekers after their completion of a STEP Project. This data is available for jobseekers who were on unemployment benefits when they commenced in a STEP project. These outcomes are measured at 6 months, 12 months and 24 months after completion of the project and ascertain if the STEP participant has reduced or ceased their receipt of income support.

As at September 2008, 55.5% of STEP participants who were in receipt of unemployment benefits at the time of commencement in STEP were receiving no benefits, or had reduced their reliance on benefits, six months after their STEP project, and 55.1% after 12 months. At 24 months after completion, the proportion of such STEP participants not receiving benefits or on reduced benefits was 61.4%.

**CA1: Senator SIEWERT**—How many staff will be based in Western Australia, in particular in the Kimberley?

**Mr Tidswell**—We have about 424 staff across what we call Area North Australia, which is the Northern Territory and the Kimberley area. I would have to take that question on notice to give you the breakdown of staff in the Kimberley versus the rest of what we call Area North Australia. Administratively we deal with the Kimberley from Darwin, which is an easy place for us to get staff in and out and to connect with.

#### **Answer:**

**CA1:** As at 30 September 2008, Centrelink had 53 employees based in the Kimberley region of Western Australia.

This number includes employees who will work across various locations in the Kimberley as part of a Remote Visiting Team.

**CA2: Senator ADAMS**—Thank you; that is good. Currently, a number of Indigenous people are being income managed. Can you give me that figure?

Mr Tidswell—Yes.

**Senator ADAMS**—What is the figure at the moment?

**Mr Tidswell**—As we speak, 15,553 customers are being income-managed.

Senator ADAMS—Thank you.

**CHAIR**—Are they all Indigenous, Mr Tidswell?

**Senator ADAMS**—I asked specifically about Indigenous people.

CHAIR—What was the answer?

Mr Tidswell—Customers.

**CHAIR**—So the answer was not on Indigenous customers?

**Mr Tidswell**—I do not think I have a breakdown for non-Indigenous persons.

**Senator ADAMS**—Is that the overall figure?

Mr Tidswell—Yes.

**Senator ADAMS**—Is that for the financial year ending 30 June 2008? How many more have you had in the past three months?

**Mr Tidswell**—I would have to take that question on notice. I am giving you figures up until 10 October. I do not have a breakdown of those figures month by month.

As at 31 October 2008, there is a total of 15,675 current income managed customers. Of these;

- 15,487 identify themselves as Aboriginal or Torres Strait Islander;
- 124 identify themselves as non-Indigenous; and
- 64 have chosen not to answer.

It should be noted that it is not compulsory for customers to respond to Centrelink's request for information about their family background, and Centrelink is not required to verify if their self identification is accurate.

#### **Question:**

CA3: Senator SCULLION—I acknowledge that, Minister, but there are only a few problem children in that area. I refer, briefly, to a number of matters that come back to Centrelink, in particular, the area of breaching. I am not confused about this issue but people talk to me about it. For example, recently when I was in a Western Desert community I was speaking to the individual who ran the CDEP program. I was there early but only a few people turned up, the longest for 10 minutes, and then they went home.

He was a bit frustrated about it but he said, 'This is the normal process.' I am not making a commentary about those issues but I said, 'What do you do now? He said, 'I ring the boss.' I asked, 'What happens then?' He said, 'They get breached and then obviously they would go off the CDEP program because they have not complied. They would then be put on another program and that would then be quarantined.' Advanced skills and a whole range of issues were a clear benefit of the community development and employment program.

Are you able to provide me with any numbers, program by program, where you have been informed by various departments that are responsible for running these programs whether there is any breaching or leverage? Can you take my question on notice and give me a rundown, department by department, of how many breaches have occurred and, generally, what the circumstances were? I recognise that there are privacy issues and I do not wish to go there, but I think that would be useful. Would you be able to do that for me?

**Mr Tidswell**—We will take that question on notice, Senator.

#### Answer:

**CA3:** Centrelink does not monitor a participant's compliance in the Community Development Employment Projects program (CDEP). It is a matter for the CDEP provider.

Where a CDEP participant is absent from, or does not participate in their activities without a good reason, they will not be paid for the period/s of non-attendance. This process is entirely managed by the CDEP provider. According to policy from the Department of Families, Housing, Community Services and Indigenous Affairs, where a CDEP participant is absent from an activity or project for more than two consecutive weeks for reasons other than approved paid leave, the provider will exit them from that CDEP program.

#### **Question:**

**CA4: Senator SIEWERT**—I refer to an issue touched on earlier by Senator Adams, that is, how many Indigenous staff are employed by Centrelink in the new Northern Australian office?

**Mr Tidswell**—Senator, I do not think I have the figures across Northern Australia, but I can give you a bit of a sense. About 170 staff are working in the field across the Northern Territory on NTER measures, and about 22 identify themselves as Indigenous staff members. On my calculations that is just under 13 per cent.

We also have our Indigenous call centres which operate out of Port Macquarie, Cairns, Palmerston, Darwin and Bunbury and, by and large, we have another 130 Indigenous staff. They are not all handling NTER related work but they are available to take calls relating to income management and to other factors. We would have to take that question on notice to give you the exact breakdown of staff across Northern Australia

#### **Answer:**

**CA4:** As at 30 September 2008, there were a total of 246 employees who identified as

Indigenous across these areas. Specifically:

- In the Northern Territory and the Kimberley (referred to within Centrelink as Area North Australia), 114 employees identified as Indigenous, 22 per cent of total employees in that Area;
- in Area Central and Northern Queensland, 110 employees identified as Indigenous, 15.7 per cent of total employees in that Area; and
- of the 170 employees delivering Northern Territory Emergency Response measures in the field, 22 (or 12.8 per cent) identified as Indigenous.

**CA6: Senator SIEWERT**—If it is appropriate could you take my next question on notice? With which organisations have you been consulting in the Cannington area and in the Kimberleys about this?

Ms Beath—We can take on notice which ones have attended our information sessions.

**Senator SIEWERT**—My question focuses particularly on Cannington but I presume that you have been undertaking similar consultation in relation to the Kimberley issue.

#### **Answer:**

**CA6:** <u>Attachment A</u> is a full list of community and Government organisations the Australian Government has consulted.

370 organisations were invited to attend seminars on the Child Protection and Voluntary Income Management initiatives in August and September 2008. The seminars were jointly delivered with the WA Department for Child Protection and the Commonwealth's Department for Families, Housing, Communities Services and Indigenous Affairs.

The seminars involved approximately 315 people and were held in the following locations: Cannington, Kununurra, Wyndham, Oombulgurri, Kalumburu, Warmun, Halls Creek, Balgo, Broome, Beagle Bay, Lombadina, One Arm Point, Bidyadanga, Loomah, Fitzroy Crossing and Derby.

In addition, Centrelink staff also attended a number of meetings and forums to discuss Child Protection and Voluntary Income Management.

Centrelink has engaged with a number of merchants and Third Party Organisations to enable income managed customers to obtain goods and services with their Income Management funds.
