# ANSWERS TO ESTIMATES QUESTIONS ON NOTICE HEALTH AND AGEING PORTFOLIO

OUTCOME 0: Whole of Portfolio Topic: HOMELESS SERVICES

Written Question on Notice

Senator Boyce asked:

In evidence before the Community Affairs Committee Budget Estimates session of May 30, a Mr Kalisch of the Department in answering questions regarding uniform and consistent data collection talked about the application from July 1 of a 'data validator' that apply to and I quote "all of the homeless services that provide us with data".

What percentage of homeless services, provide data? [Please provide figures state by state.]

### Answer:

The latest publicly available data on homelessness service agencies is from the 2009–10 Supported Accommodation Assistance Program National Data Collection. In 2009–10, 92 per cent (or 1,434) of all funded agencies (1,559) were required to participate in data collection (Table 1).

Not all funded agencies are required to participate in data collection. States and territories determine the requirement to collect data. For example, some agencies are soup kitchens and could not be reasonably expected to collect data. Of the 1,434 agencies that were required to participate in data collection, 93 per cent (or 1,338) required to supply data actually provided data to the Australian Institute of Health and Welfare (AIHW) (Table 2).

About 86 per cent (1,338 of 1,559) of funded homelessness service agencies provided data in 2009–10.

The AIHW does not have information on unfunded homelessness service agencies but understands that they are likely to be few in number.

The new Specialist Homelessness Services (SHS) collection commenced on 1 July 2011 and will use improved data validation arrangements including Validata<sup>TM</sup>, a tool developed by the AIHW to help improve the timeliness of data provision. The SHS collection agencies submit data to an AIHW webportal. This data is passed through the Validata<sup>TM</sup> which applies a range of data checks and edits and presents a report back to agencies for any corrections required. This automated process is more efficient than the past manual process, resulting in significant gains in the timeliness in processing data.

- Inclusion or exclusion of agencies from the SAAP NDC is determined by the state and territory governments responsible for administering the government response to homelessness.
- 2. Not all funded agencies are required to participate in data collection. Agencies required to participate in data collection are termed 'participating agencies'. Agencies not required to participate in data collection are termed 'non-participating' agencies.
- 3. In 2009–10, 5 participating agencies in NSW; 6 in Victoria; 3 in Qld; 2 in SA; and 1 in NT were notified to AIHW as being unable to provide data for the entire reporting year. These participating agencies are excluded from the count of participating agencies in this table and included in the count of non-participating agencies.
