Senator Waters asked:

Senator WATERS: Under section 516A of the EPBC Act, all Commonwealth agencies, authorities and companies have very broad obligations as part of their annual reports to report on how their activities accord with the principles of ESD, ecologically sustainable development. Obviously, this can be a fairly large task and I do not assume that all agencies have that expertise in house. What support does SEWPaC provide to those other agencies to make sure that they can comply with their obligations? Do you have experts on hand to review their draft reports or, more importantly, to review and advise on the operations of those other agencies?

...

Mr Thompson: There is a small team within our Corporate Strategies Division which helps prepare the guidelines which are available on the web and which also provides advice on request to departments. I think your comment went to whether we look at drafts of reports provided by departments.. I am not aware that they provide that extensive a level of support, but they are in a position to answer questions about the collection of information, the use of indicators and those sorts of things across a range of measures, including things like stationery use, waste, water use et cetera.

Senator WATERS: Perhaps you might help me with a follow-up question as well. You said that SEWPaC does provide advice to those other agencies. Can you tell me how many agencies in the last three reporting cycles have sought such advice, what kinds of questions were asked and what advice was given.

Mr Thompson: I am sorry, I do not have that information.

Senator WATERS: Are you able to take that on notice?

Mr Thompson: I can take it on notice.

Answer:

The Department of Sustainability, Environment, Water, Population and Communities (the department) provides general guidance and advice to other agencies on annual reporting under section 516A of the *Environment Protection and Biodiversity Conservation Act 1999* (the EPBC Act).

Updated guidance on reporting was published on the department's website in July 2010 upon request of the Department of Prime Minister and Cabinet. Both written and verbal advice is provided as required.

The department's Community Information Unit keeps records of all written enquiries from the past 15 months. These records show there have been no enquiries from other agencies on annual reporting under section 516A of the EPBC Act.

Under the department's Environmental Management System managed by the department's Environmental Performance Team, records are kept of all internal and external queries related to the Environmental Management System including environmental performance and reporting. Again these records for the past three years indicate there have been no written queries from other agencies.

The department may have fielded some enquiries via telephone directly to officers however no formal records exist of these queries.

Officers from the department also participate in the Government Agencies Environmental Network which was formed in March 2007 to provide opportunities for information sharing and networking between public service agencies. The primary objective of this group is to facilitate better understanding of policies and initiatives, discuss issues and better practice to help drive environmental performance improvements within public sector agencies, and to share information on implementation and reporting. The issue of environmental reporting including section 516A annual reporting is discussed regularly and a sub group on Metrics and Reporting has been formed to which the department contributes.

Senator Waters asked:

Senator WATERS: Finally, what analysis has SEWPaC done to ensure that ESD is in fact being fully incorporated into the department's own decisions as intended by 516A?

Mr Thompson: An environmental management committee operates in the department and it looks on a regular basis at the various measures that we use to indicate how we are dealing with ecologically sustainable development principles in relation to the EPBC Act. That then informs not only the reporting that we do on a regular basis but also where we can improve that performance.

Senator WATERS: If you could table a little bit more information for me on that aspect, that would be very helpful.

Mr Thompson: I will see if I can do that.

Answer:

The department reports annually under section 516A on how the department's activities accord with and contribute to ecologically sustainable development (ESD) and on the department's environmental performance. These Annual Reports are published on the department's website. Each annual report includes an analysis of the impact of the department's activities on the natural environment, how these are mitigated and how they will be further mitigated.

In late 2009, the department formed an executive committee called the Departmental Environmental Performance Committee which includes representatives from the Australian Antarctic Division, Parks Australia and the Supervising Scientist as well as the Chief Operating Officer. This Committee meets twice a year to consider strategic approaches to whole-of-department environmental performance and management.

This Committee has examined and informed initiatives such as the Australian Government ICT Sustainability Plan and the Australian Packaging Covenant's Australian Government Action Plan. The Committee reviews and discusses the annual reports of the different areas within the department such as the Canberra and Darwin Offices, our parks and reserves, and the Australian Antarctic Division to see how the department is performing environmentally and how the ecologically sustainable development principles have been incorporated into the operations and decisions of those areas. Additionally, the department has two Environmental Management Systems which are certified to the international standard for environmental management (ISO 14001:2004). An Environmental Management System provides a systematic, accountable and well documented approach to mitigating the environmental impacts of the department's activities. These Environmental Management Systems cover the operations of the Canberra Offices and the Australian Antarctic Division.

Senator Birmingham asked:

- 1. How many staff are currently employed in the Department across all program areas?
- 2. How many staff will be employed in the Department at the end of this year across all program areas?
- 3. What is the number of permanent and contracted staff?

Answer:

- 1. As at 31 January 2012 there were 3,090 employees in the Department of Sustainability, Environment, Water, Population and Communities (the department).
- 2. It is expected that staffing numbers in the department will not change significantly by the end of this year.
- 3. As at 31 January 2012 there were 2,420 ongoing (permanent) employees and 670 non-ongoing (temporary) employees.
- 4. The total operating budget (Net Costs of Services/Departmental Appropriation) for the department is \$481,572 million; the total employee expense budget is \$239,730 million.
- 5. The department currently does not have a mechanism to fully capture and record details centrally of all learning and development activities undertaken by employees, nor the total expenditure on this function. Efforts are underway to improve the capture of data in this regard.

The department provides staff with opportunities to access job related learning and individual career development activities including in-house training organised and/or delivered by divisions, corporate expert areas of the department (for example, financial management and procurement) and the central workforce development function; training and development sourced externally to the department; and support to undertake external study through educational institutions. While it is not possible to give a comprehensive report on all learning and development activity and expenditure across the department, it is possible to report on training packages organised and/or delivered through the department's central workforce development function. These are reported in a) below.
