Senator Urquhart asked:

Senator URQUHART: Can you tell us how much land is designated as national park in

Ms West: As national parks as a whole, not just Commonwealth parks?

Senator URQUHART: Can you do them separately?

Ms West: No, I would have to take that on notice for the whole of parks reserves.

Senator URQUHART: Leave out the Commonwealth parks and provide that on notice. Are you

able to do the other one?

Mr Thompson: Just to clarify, the Director of National Parks looks after Commonwealth parks and then there are a whole series of other terrestrial and marine reserves which are declared as state national parks. The Director of National Parks has properties in Booderee, Pulu Keeling, Christmas Island, Kakadu, Uluru and the Botanic Gardens.

CHAIR: If you were to answer the question in relation to the area of the state national parks and territory national parks, it would be a pretty big job for you to research all of that, wouldn't it?

Ms West: Yes, that information would be available but I do not have it today.

Senator URQUHART: That is all right—the information on Commonwealth parks is adequate. Ms West: I have not got this added up, but even just taking Kakadu, it is two million hectares, so there is quite an area there. Booderee is 6,000 hectares, Uluru is 1,320, Christmas Island is 8,000 hectares, Norfolk Island is 600 and Pulu Keeling is about 2,600.

Answer:

The figures in Table 1, for terrestrial protected areas in the states and territories, have been sourced from the Collaborative Australian Protected Area Database (CAPAD). The information is current up to 31 December 2012. These figures do not include Commonwealth terrestrial protected areas.

^{*} These area figures are based on "Reported Area". If the State and Territory agencies provide us with the Gazetted area we use that, otherwise if Gazetted Area not provided then we use GIS Area. So effectively the "Reported Area" is a blend of 2 figures.
