5. Cape Ferguson site- Main building complex including North & South wing 81%, Workshops 100%, Marine Operations 100%, Seawater Precinct 79%, Seasim 82%.

These occupancy rates are based on office space available in each building and not on a square meter rate. AIMS is a scientific research facility that is comprised of laboratories, climate controlled stores, controlled environment rooms for marine research, a seawater processing and reticulation system. Spare office space is required for visiting scientists and university students undertaking collaborative research work with AIMS.

AIMS' vessel berthing facility is used to house the AIMS vessels the *RV Cape Ferguson* and *RV Solander*. The facility also contains a lock up storage shed for field equipment and amenities requirements for the ship's crew whilst in port.

AIMS also holds tenancy space of 586m<sup>2</sup> at the Indian Ocean Institute at the University of Western Australia Crawley Campus.
