ANSWER

The details of the non-legal consultants engaged by ANSTO from 1 May 2008 until 30 April 2009, in response to questions a) - d) and f) - i), are outed in the table below. During the period 1 May 2008 until 30 April 2009, a total of \$444,788.07 (excluding GST) was paid by ANSTO to non-legal consultants.

Regarding question e), ANSTO has paid approximately \$742,000.00 (excluding GST and including disbursements) to external legal providers from 1 May 2008 until 30 April 2009.
