#### Question

## REWARD PAYMENTS FOR IMPROVING PARTICIPATION RATES AND RATES OF YEAR 12 ATTAINMENT

The 2009-10 Budget provided \$100 million to the States and Territories as reward payments for improving participation rates and rates of year 12 attainment. To clarify, does this funding come from the \$623 allocated for the entire commonwealth contribution to the National Partnership? What are the indicators for improving participation rates that will trigger the reward payment to the States and Territories? And in terms of Year 12 attainment rates, are the reward payments based upon reaching the 90 per cent?

#### **Answer**

The \$100 million in reward funding is in addition to the \$623 million allocated by the Commonwealth to the National Partnership on Youth Attainment and Transitions. This brings total Commonwealth funding under the National Partnership to \$723 million.

The reward funding will be made available based on the achievement of participation (2010) and attainment (2012) targets agreed under the National Partnership on Youth Attainment and Transitions, as assessed by the COAG Reform Council.

Both targets were set to act as progress measures for the COAG90 per cent Year 12 or equivalent attainment by 2015 target.

Reward payments for the 2010 participation targetswill be made available based on achievement against improved participation of young people as outlined under the National Partnership (see table below). This will be measured by the total number of full-time enrolments in Years 11and 12 plus 15-19 year olds enrolled in VET, but not in school and not previously attaining a Year 12 certificate or equivalent or an Australian Qualifications Framework (AQF) Certificate II or above in 2010.
