#### Question

# \$42 MILLION FOR NATIONAL CAREER DEVELOPMENT INITIATIVES

Under the Partnership, the Commonwealth will also be providing \$42 million for national career development initiatives. There doesn't seem to be any progress made on this programme. What initiatives have been funded since 1 January 2010, and at what cost for each initiative?

# Answer

- Under the Youth Attainment and Transitions National Partnership Agreement (the "YAT NP") the Australian Government is providing \$47 million from 2009-2014 for national career development initiatives administered by the Australian Government. The purpose of this funding is twofold: to provide resources that it makes sense to do at a national level and to develop a strategic approach to career development.
- Since 2010 the Australian Government has provided funding out of this \$47 million for a range of career development initiatives and resources delivered nationally (listed in *Table 1* below).

#### The National Career Development Strategy Research Project

- The Australian Government (through DEEWR), in collaboration with jurisdictions, is undertaking a Research Project to develop a National Career Development Strategy that will deliver advice to government on how to provide improved and strategic career development support to all young Australians (aged 5-24 years).
- DEEWR is currently conducting a four-stage research project which will deliver a series of reports in 2011 which will advise on the following:
  - national and international best practice in career development and analysis of the range and effectiveness of existing Australian Government and state career development programs;
  - 2. the career needs and wants of young people from the ages of 5-24, their parents, career practitioners, teachers and employers;
  - 3. recommendations for improvements to career development nationally and options for a national strategy for career development support for young people; and
  - 4. a cost-benefit analysis showing the advantages and disadvantages to the Australian economy of adopting a particular approach to career

development support for all young Australians.
