National Employment Standards fact sheets

Senator ABETZ: ... The Fair Work Ombudsman has on its website, or refers people on its website, to the 10 National Employment Standards and fact sheets behind that. Are you able to tell us which one of those is downloaded the most? Do you have a system to determine that? Mr Wilson: We do. Senator ABETZ: Is that readily available and, if not, can you take it on notice? Mr Wilson: We will have to take that on notice. Senator, but we do track the downloads of that sort of information, ves. Senator ABETZ: Are you able to tell us of those 10 National Employment Standards the order in which they are enquired about—which are downloaded the most but also which you get the most telephone calls or letters or emails about? Are you able to dissect that or not, without too much work? Mr Wilson: We can give you some information. It will not be a precise correlation but we can say the standard National Employment Standards, the 10 matters, and then we can say that through the telephone service we have this many calls about annual leave, this many calls about public holidays—we can do that kind of dissection. But it is not precisely about the National Employment Standard itself. Senator ABETZ: All right. As good as you can get it—I would appreciate it.
