DEED OF TERMINATION OF CONTRACT

THIS DEED OF TERMINATION OF CONTRACT is made on 20 H day of A 150 9 2003

BETWEEN the

COMMONWEALTH OF AUSTRALIA ("the Commonwealth") represented by the Department of Employment and Workplace Relations, Sydney NSW, ABN 40 376 417 416 ("the Department")

AND

SEAWIND GROUP PTY LTD of 16 Industry Drive, Tweed Heads South NSW 2468 ABN 26 099 128 962 (the "Provider")

BACKGROUND:

- A The parties entered into an Indigenous Employment Program Structured Training and Employment Project Contract on 6 January 2003 ("the Principal Contract").
- B. The parties now wish to terminate the Principal Contract. In order for such termination to take effect, the terms of the Principal Contract must be varied.
- C. Clause A3.2 of Schedule A of the Principal Contract requires that such variation be in writing and signed by both parties.

THE PARTIES AGREE

- 1. Upon execution of this Deed of Contract Variation, the Principal Contract shall be taken to be varied as follows:
 - in clause 2.1, delete '5 February 2004 ('the End Date') or upon the conclusion of any Audit of the Project (which has commenced before the End Date), whichever is the later', and insert:

"the date on which the Provider and the Commonwealth execute a Deed of Termination of Contract, provided the Provider has

- (a) completed an Acquittal to the satisfaction of the Department; and
- (b) has returned to the Department all Establishment Funding not spent on the activities or items specified at subclause 5.2."
- Upon satisfaction of all the conditions set out in clause 1 of this Contract Variation, the Provider and the Commonwealth shall, be taken to be discharged of their obligations arising out of the Principal Contract, except to the extent that such obligations would, apart from the operation of this clause, otherwise survive the termination of the Principal Contract by operation of clause A13 of Schedule A of the Principal Contract.
