Question

National Green Jobs Corps - Completions And Withdrawals By State And Territory

Senator ABETZ: Can you provide a certain date, a breakdown by state and territory, how many participants have completed the program, and what percentage thus far have withdrawn from the program early? Then can you indicate to us the reason, if it is available, they have withdrawn?

Answer

There are a number of reasons a participant leaves the National Green Jobs Corps program. When a participant exits a place, for whatever reason, the provider can commence another participant in that place.

National Green Jobs Corps providers will advise a participant's referring agency (Centrelink, Job Services Australia or Disability Employment Service provider) of their exit and exit reason. The referring agency will then, where appropriate, take action to ensure the participant undertakes activities that meet their individual needsand satisfy their activity test or participation requirements.

The reasons participants leave National Green Jobs Corp are detailed below:

Employment and	Participant has left the program prior to completing 26 weeks to

	commencement in a project. Once it has been determined by
	Centrelink that these participants are not eligible to participate in the
	program, the National Green Jobs Corps provider is required to exit
	them.
