Answer

- 1. The Department did not record travel data in a way that would readily allow answers to be provided for this question.
- 2. The total cost of travel for the Department for the 2012–13 financial year to 31 May 2013 was \$7,590,563. To provide the requested level of detail would require an unreasonable diversion of resources.
- 3. Travel planned for the remainder of the financial year was \$690,051. To provide the requested level of detail would require an unreasonable diversion of resources.
- 4. The department was abolished on 18 September 2013.

- 5. Business Class airfare tickets are approved for SES travel and for all staff travelling overseas. In the Department there was a reduction in business class flights in line with the media release dated 25 September 2012. Business Class fares represent 11.7 per cent of airfares this financial year, compared to 13 per cent of airfares during the 2011–12 financial year.
- 6. Yes, lounge memberships are provided to employees if they meet the qualification requirements. An employee qualifies for consideration for lounge membership where it is anticipated that eight or more business trips will be required to be undertaken in a 12 month period. The memberships are provided to ensure that frequent travellers have a professional environment from which they can work while waiting for flights, and also to ensure that they arrive as prepared as possible to represent the Department.

A breakdown of the lounge memberships at 31 January 2013 is provided below.
