PROFESSIONAL FEES PAID TO PANEL MEMBERS AND ADVOCATES

On notice, I would like to know who is on the panel and, of those who are on the panel—and this is both for solicitors and advocates—how much they were paid over the last financial year.

The CEO responded — Yes.

Answer

Comcare has provided the following response:

Comcare's legal services arrangements consist of the Legal Services Branch with access to external legal services through a panel arrangement. The Legal Services Branch is led by General Counsel, who is a member of Comcare's Executive. General Counsel manages the Legal Services Branch as well as the panel of external legal service providers to assist Comcare to achieve its outcomes in an efficient and cost-effective manner.

In 2008-09, Comcare's total legal expenditure was \$27,583,073.

Of that, Comcare spent \$19,812,210 on external legal services and \$7,770,863 on internal legal services. Comcare's legal expenditure is calculated and reported in accordance with paragraphs 12.3(f) and 11.1(da) of the Commonwealth's *Legal Services Directions 2005* expenditure reporting requirements.

Comcare does not maintain a panel in respect of Counsel or advocates. Comcare engages Counsel in accordance with Appendix D of the *Legal Services Directions 2005* and Counsel are paid in accordance with their rate approved by the Office of Legal Services Coordination in the Attorney-General's Department.

Comcare incurs legal expenditure across three functions that include the management of premium and pre-premium claims under the *Safety, Rehabilitation and Compensation Act 1988*, compliance and enforcement activities related to the *Occupational Health and Safety Act 1991* and management of common law asbestos liabilities under the *Asbestos-related Claims (Management of Commonwealth Liabilities Act) 2005*.
