JOB SEEKER ASSISTANCE DATA

Please provide the following data regarding jobseekers assisted by JSA providers during the last quarter for which these data are available:

i. The number of jobseekers (disaggregated by duration of unemployment, broad age categories, sex, disability status and Indigenous status) in each Stream

ii. The number of jobseekers (disaggregated in the same way)within each Stream in the work experience phase

iii. Average full and part time employment outcomes (disaggregated in the same way) three months after completion of participation in each Stream (where 'completion' refers to exits from JSA, upgrading to a different stream, or completion of the first 12 months of activity within a Stream) or if this is not available, full and part time employment outcomes six months after commencing in a Stream

iv. Average full and part time employment outcomes (disaggregated in the same way) six months after commencement of the work experience phase of assistance (for those who have commenced over 6 months ago)

v. The overall proportion of jobseekers in each Stream, both prior to and during the work experience phase, attracting pathway outcome fee payments and full outcome fee payments respectively

vi. Average expenditures from the employment pathway fund for each Stream both prior to and during the work experience phase, disaggregated by broad categories of expenditure (e.g. work experience, training).

iv. The Department does not measure employment outcomes six months following commencement in the Work Experience Phase. The Department through the PPM survey measures the outcomes of job seekers three months after either they exit the Work Experience Phase or reach 12 months in the Phase. At present it is not possible to report outcomes for the Work Experience Phase as there have been insufficient number of job seekers who have reached 12 months in the Work Experience Phase to be able to calculate robust outcome estimates. PPM survey results for the Work Experience phase should be available in late 2011.

v. The total number of 13 Week Pathway and Full Outcomes and proportions, by Stream for the period 1 July 2009 to 31 August 2010 is shown below.

* EPF Debits – reflects reimbursements and commitments for purchases under EPF (recording a commitment enables a provider to set aside funds for a specific purchase without risk that these funds being drawn down for another purpose i.e. prior to when the purchase can be finalised).

Some EPF expenditure is not recorded against individual job seekers and has not been attributed to the averages - this includes Work Experience activities and batch purchases under \$300 (for example a book of bus/train tickets distributed to a number of job seekers over time).

** The category of 'Other' includes includes miscellaneous EPF Debits categories (for example: Stream 4 Assistance, Short Term Child Care Assistance, Relocation Assistance).
