Question

JSA stream 4

Senator SIEWERT: Against the criteria for stream 4; do you do an analysis of those that are on there and if the 20 per cent of their significant disadvantage is homelessness? Do you know what I mean? You could look at what the characteristics are of that cohort of people.

Ms Parker: Yes. The difficulty we have again is the multiple stuff. We would be able to tell you that there are this many job seekers with 17 disadvantages and some with eight, and how many with four.

Senator SIEWERT: But do we know what they are? Is there a common thread across that? If mental health turns up in— Ms Parker: In how many categories?

Senator SIEWERT: Yes.

Ms Parker: Can we take that on notice and we will have a look?

Senator SIEWERT: Yes.

Answer

As part of determining a job seeker's eligibility for Stream 4 a job seeker will undertake an Employment Services Assessment (ESAt). All ESAt assessments are conducted by qualified health and allied health professionals, such as psychologists and registered nurses employed by a single government provider under the Department of Human Services portfolio.

An ESAt identifies the job seeker's vocational and non-vocational barriers to finding and maintaining employment, their work capacity, support requirements and recommends appropriate interventions. Stream 4 providers may use the findings and recommendations in the ESAt to tailor assistance to the job seeker.

The following table shows the most commonly identified barriers as recorded in the ESAt for all Stream 4 job seekers on the JSA caseload as at 31 August 2011. It is important to note that Stream 4 job seekers are likely to have multiple disadvantages and therefore an individual job seeker may be counted a number of times against barrier categories in the table.
