(e.g. 1 child, 2 children, 3, etc)? • How many report being of Indigenous/non-Indigenous background? • How many receive Carer Allowance? How many receive CA for 1, 2, 3 children, etc. (Provide data for Carer Allowance Child and Adult, if possible). • How many have one (or more) vulnerability indicators? As at 31 August 2012, there are 110 581 Grandfathered Parenting Payment Single recipients who would be impacted by the 1 January 2013 changes to Parent Payment eligibility, and of this number 67 221 will be impacted immediately on this date.
