## Senator Ronaldson asked:

With the greatest respect, the airlines are not sitting at this table but the department is, and this committee has responsibility for ascertaining the budget spend. Surely if there are claimed savings of \$160 million, and given this has been done on a department by department basis, you can provide the committee with a departmental breakdown of savings.

## Answer:

The individual agency amounts returned to the Budget in 2010-11 are listed in <u>Attachment A.</u> The savings are calculated using the 2007-08 travel profile and applying the Request for Tender pricing to that profile.

In line with the decision of Government, the Department of Defence is able to retain its savings for re-investment to offset new policy priorities.

The Australian Prudential Regulation Authority (APRA) did not return savings to the Budget as it is industry funded. A reduction in APRA expenses will be matched by a reduction in industry funding revenue, so there is no net budget savings.
