## SUPPLEMENTARY ESTIMATES HEARING 18 NOVEMBER 2013 – DEPARTMENT OF THE SENATE ANSWERS TO QUESTIONS TAKEN ON NOTICE

At the hearing on Monday 18 November 2013, the Department of the Senate took questions on notice. The discussion and questions covered a range of areas, and the responses are provided below.

(a) How the request for the bookcase was made

Requests for service by senators are typically made in a number of ways: e-mail, telephone call, and informal discussions.

The relevant file indicates that the request was made in person by Senator Brandis to the former Usher of the Black Rod (Ms Andrea Griffiths). A copy of the e-mail advising of Senator Brandis's request is attached at Attachment A.

The purchase of the bookcase was approved by the then Deputy Black Rod (Mr Nick Tate) in accordance with the Financial Management and Accountability Regulations 1997. The supporting financial documentation is at Attachment B.

(b) How the bookcase was moved and the cost of moving

As I indicated in my evidence on 18 November 2013, the movement of the bookcase in May 2010 was carried out by an external contractor, Right Now, which was engaged to carry

out a range of tasks for senators and the department. The total cost for these tasks for the period was \$1,014.75.

A copy of the invoice (and associated informal list of tasks for the period) is attached at Attachment C.

## (c) The process for assessing a request from a senator

As part of its service to senators, the Department of the Senate may, from time to time, provide additional furniture to senators. When receiving a request from a senator for additional furniture, the approach of the department is to first examine its existing holdings of furniture to determine whether the request may be met from those holdings.

Where the department does not hold a particular item, the department may seek to borrow the item from other parliamentary departments. If this is not possible, it may seek to purchase the item externally. Each request is examined on a case-by-case basis by the Usher of the Black Rod (or her delegate) having regard to a range of factors, including relevant Commonwealth procurement guidelines, the cost of the request and the utility of the item to be purchased.

## (d) A list of additional furniture provided to senators

Since January 2008, the department has purchased four items of specific furniture for senators:

(e) The consultation process for the bookcase, specifically design integrity

The file indicates a range of internal departmental and external discussions were held in respect of the procurement of the bookcase, but the full details of those discussions are not

recorded on the file. However, an e-mail on the file indicates that the Department of Parliamentary Services (which has responsibility for design integrity issues) was consulted in respect of the wood to be used for the bookcase and the overall design. A copy of this e-mail is attached at Attachment G.

(f) The request to move the bookcases to the Ministerial Wing

Finally, in the context of a discussion relating to the possible loan of the bookcase, I note that I provided evidence suggesting that the bookcase would not fit within the Senator Brandis's ministerial office because of the curved configuration of the building. We understand from the Department of Parliamentary Services that the bookcase in its entirety would not fit into Senator Brandis's current office, but it is an assumption on our part that this was due to the building's configuration.
