Senator Eggleston asked:

(1) What is the status of each election commitment within the portfolio?(2) Which election commitments are experiencing slippages? Why? Where relevant, what are the revised implementation dates? What are the implications of this slippage?

Answer.

The following table reports the status of pre-election commitments on specific immigration and citizenship issues, including those that were referred to the (then) Department of Finance and Administration for costings under the *Charter of Budget Honesty Act 1997*.

Changes from that reported in response to a similar Question on Notice from the October 2009 hearing of the Legislation and Constitution Affairs Committee are reported in italics.
