Question No. 104

Senator Humphries asked the following question at the hearing on 25 May 2010:

- a) How many car spaces does the Commonwealth own in the Parliamentary Triangle?
 - i. Can this also please be broken down, by agency or by location?
- b) How many car spaces does the Commonwealth allocate to staff within the Parliamentary Triangle?
 - i. Can this also please be broken down, by agency or by location?
- c) Has the Government sought any modelling on the impact of the imposition of paid parking in the Parliamentary Triangle?
 - i. If so, can that please be provided?
- d) If paid parking in the Parliamentary Triangle were to be imposed, would the Australian Government be liable to pay fringe benefits tax for the car spaces that it owns?
- e) Has there been any correspondence between the Minister and the ACT Government on the issue of paid parking in the Parliamentary Triangle?
 - i. If so, what was the date of that correspondence?
 - ii. If so, who was the correspondence with?
 - iii. If so, what was the nature of that correspondence?
 - iv. If so, can that correspondence be provided?

The answer to the honourable senator's question is as follows:

a) In November 2009 the National Capital Authority (NCA) on behalf of the Intergovernmental Committee on Parking (IGC) engaged Datacol Research Pty Ltd (Datacol) to undertake parking surveys within the Parliamentary Zone, Barton and Russell. All parking within the Parliamentary Zone is located on land managed by the Australian Government.

There are a total of 7243 car parking spaces within the Parliamentary Zone, of which 6690 were surveyed by Datacol during November-December 2009, and in March 2010. The House of Representatives car park at Parliament House was not surveyed by Datacol as access for survey purposes was denied. The ACT Government Department of Territory and Municipal Services have indicated that this car park contains 553 spaces.

Attachment A provides details of off-street parking supply by location (including maps), along with details of on-street parking. Utilisation rates (or demand for parking) are also included. This attachment includes only those car parking spaces surveyed by Datacol.

- b) Of all parking within the Parliamentary Zone, 351 car parking spaces require a 'B Class' (or Government vehicle) permit to park. Of these:
 - 312 spaces are located off-street and are long-stay parks;
 - 14 spaces are located off-street and are short-stay parks; and
 - 25 are located on-street and are long-stay parks.

Some of these spaces are indicated as 'reserved' (for example by a name plate) however there is no legal mechanism to enforce the reservation of these spaces. There are also a number of other car parks indicated as 'reserved' and no Government permit is required, however again there is no legal mechanism to enforce the reservation of these spaces.

Holders of 'B Class' permits are not guaranteed a parking space in a particular location. Reciprocal agreements between Government agencies (including the ACT Government) mean that any Government employee with a 'B Class' permit may park in any space indicated as requiring the permit to park.

Other car parking spaces do not have the above restrictions, however are within areas with restricted access for use by employees of particular Government agencies or Parliamentarians only. Restricted access parking includes car parking spaces located in areas where a pass (allocated only to a limited number of people) is required to go through some form of physical barrier (such as a boom gate).

The following list provides details of where long-stay off-street Government permit parking is located, and where restricted access parking is located within the Parliamentary Zone:

- John Gorton Building and surrounding car parks 133 spaces require a Government permit to park; and a further 29 spaces are within a restricted access parking area;
- Questacon 65 spaces are located within a restricted access parking area;
- National Gallery of Australia 17 spaces require a Government permit to park; and a further 179 spaces are within restricted access parking areas;
- High Court 128 spaces are within a restricted access parking area;
- National Portrait Gallery 38 spaces are within a restricted access parking area;
- Treasury Building and surrounding car parks 88 spaces require a Government permit to park;
- National Library of Australia 12 spaces require a Government permit to park;
- West Block 28 spaces require a Government permit to park;
- East Block 9 spaces require a Government permit to park; and
- Parliament House 1488 are within restricted access parking areas. This figure includes those car parks within the House of Representatives car park not surveyed by Datacol. Twenty-five of these spaces (within the Senate and Ministerial car parks) require a Government permit to park.

All off-street short-stay parking spaces are located at Parliament House.

The 25 on-street long-stay parking spaces are located in small numbers (2-7 spaces) around the High Court, on Newlands Street, Parkes Place East, Parkes Place West, Parliament Square East, and Parliament Square West.

c) In April 2009 the NCA on behalf of the Intergovernmental Committee on Parking (IGC) engaged GTA Consultants (GTA), a specialist transport and parking management consultant, to develop car parking management strategies for National Land in Barton, Parkes and Russell. GTA will investigate various car parking management options available, including pay parking, and will provide recommendations to the IGC.

GTA are scheduled to provide draft car parking management options to the NCA by end July 2010. Once the IGC have finalised their recommended approach to parking management, a report on the approach and associated implementation plan will be made public.

d) The implementation of paid parking in the Parliamentary Zone has the potential to affect individual Government agency budgets. Australian Government agencies could attract a Fringe Benefits Tax (FBT) liability for each parking space provided to an employee.

An FBT liability will eventuate where the employer provided parking is within one-kilometre of a commercial car parking station that charges more than the car parking threshold (\$7.25 for the 2009-2010 FBT year which ran from 1 April 2009 to 31 March 2010).

e) On 14 July 2009 the Minister for Home Affairs, the Hon Brendan O'Connor MP, wrote to the ACT Chief Minister supporting his suggestion that a joint working party be formed to consider parking options in the Parliamentary Zone and Russell and advising that an Intergovernmental Committee on Parking would be convened to assist in resolving the long standing parking issues in the Parliamentary Zone and adjacent areas. This letter also sought nominees from the ACT Government to participate in the IGC. A copy of this correspondence is attached.

Figure 1: Off-street parking within the Parliamentary Zone (Capital Hill)




Figure 2: Off-street parking within the Parliamentary Zone (north of Capital Hill)


