Question No. 100

Senator Fisher asked the following question at the hearing on 19 October 2009:

How many officers of AUSTRAC have undertaken overseas travel in the last year?

- a) For what purpose was this travel,
- b) what was the cost of the travel,
- c) please provide the details of each overseas trip taken, including all destinations and stop overs, durations stayed at each location, the official duties undertaken at each stop, and the total cost and total duration of each trip, and
- d) please provide the total cost for overseas travel incurred by AUSTRAC officers this year.

The answer to the honourable senator's question is as follows:

Between 6 October 2008 and 18 October 2009, AUSTRAC officials undertook 76 overseas trips. The total cost to the agency of overseas travel for this period was \$622,101.91. Please see the attached table for detail.

Each item represents travel by one official. Where there has been travel by two or more officers to the same destination, differences in total travel costs may arise as some costs were attributed to one official, rather than spread among officials. For example, one officer may have paid the accommodation costs for the entire delegation. Also, AUSTRAC costs may have differed according to the level of entitlement provided to the officer, if any.
