## Question No. 2

## Senator Barnett asked the following question at the hearing on 19 October 2009:

Since Budget Estimates;
a) how many employees have been employed on contract, and what is the average length of their employment period,
b) have staff numbers been reduced as a result of the efficiency dividend and/or other budget cuts? If so, where and at what level, and
c) are there any plans for staff reduction? If so, provide relevant details.

## The answer to the honourable senator's question is as follows:

Since Budget Estimates;
a) Since 28 May 2009, 35 new employees have been employed on non-ongoing contracts. The average length of the employment period was 116 days.
b) Since Budget Estimates there has been an overall reduction of 78.1 FTE. Staffing numbers are determined by a range of factors including the effect of the efficiency dividend, the impact of salary increases, changes in overall priorities and the alignment of resources to those priorities.
