- 7) What entertainment spend is the Department/Agency's planning on spending? Detail date, location, purpose and cost of all events.
- 8) For each Minister and Parliamentary Secretary office, what entertainment spend is currently being planned for? Detail date, location, purpose and cost of each event.

The answer to the honourable senator's question is as follows:

The Office of the Commonwealth Director of Public Prosecutions and the Office of Parliamentary Counsel have not incurred any hospitality or entertainment costs for 2010-2011 or FYTD. For operational security reasons it would be inappropriate for the Australian Security and Intelligence Organisation to respond to part 1) and part 5).

All stated financial figures are GST exclusive.

Attachment B provides details on spending in between 1 July – 18 October 2011 for the Attorney-General's Department, AFP and the High Court of Australia.

The Australian Commission for Law Enforcement Integrity, Australian Human Rights Commission and CrimTrac have no significant events planned for 2011-12.

The Australian Crime Commission has been allocated \$15 000 to the 2011-12 financial year to fund a similar scope of stakeholder functions as occurred in 2010-11.

As the provision of official hospitality/entertainment is infrequent and incidental in nature and is therefore not a core component of the agency's activities, Customs and Border Protection does not budget separately for these items.

The High Court of Australia has planned to cater two public lectures, one in November 2011 and one in June 2012. Each has been allocated \$3 000.

The Australian Law Reform Commission is forecasting a similar level of expenditure for 2011-12 as it incurred in 2010-11.

ITSA has no defined plan to spend on specific hospitality/entertainment during any period although would expect to incur minor expenditure in these categories.
