#### **Question No. 92**

### Senator Humphries asked the following question at the hearing on 18 October 2011:

### **Board Appointments**

- a) What is the gender ratio on each board and across the portfolio?
- b) Detail any board appointments for the year 2010-11.
- c) Please detail any board appointments for the FYTD.

## The answer to the honourable senator's question is as follows:

a)

As at 18 October 2011, the gender ratio of active appointments (including reappointments and acting appointments of three months or more, but excluding standing acting appointments) on 39 boards/bodies<sup>1</sup> across the Attorney-General's portfolio is set out in the table below:

The Commonwealth does not exercise any control over State and Territory representatives. ACC Examiners are appointed as statutory office holders.
