### SUPPLEMENTARY BUDGET ESTIMATES HEARING: 15 October 2012

IMMIGRATION AND CITIZENSHIP PORTFOLIO

## (SE12/0026) PROGRAM - OMARA

Senator Cash (L&CA 17) asked:

I also refer you to the answer given to BE12/0019, which states: 'In the period from 1 July 2009 to 31 May 2012 ten agents were sanctioned by the Office of the Migration Agent Registration Authority (the Authority) as a result of mishandling client monies. ... Three of the Authority's decisions are currently subject to an appeal to the Administrative Appeals Tribunal (AAT).' Have there been any developments in those cases?

#### Answer:

Two further agents were identified since the previous answer was given following careful review of the data based on a refined definition of mishandling client monies.

Mishandling of client monies includes a registered migration agent failing to maintain a client account in accordance with their obligations under the Code of Conduct or receiving client fees without providing services.

In the period 1 July 2009 to 31 May 2012, 12 agents were sanctioned as a result of mishandling client monies.

Of these 12 sanction decisions, four appeal applications were lodged with the Administrative Appeals Tribunal.

Of these four appeal applications, one application was withdrawn by the review applicant and one application was dismissed by the AAT. Two review applications are currently ongoing.
