Senator Ludwig (Written) asked:

For all departments and agencies, please provide – in relation to all public relations, communications and media staff – the following: By Department or agency: a) How many ongoing staff, the classification, the type of work they undertake and their location. b) How many non-ongoing staff, their classification, type of work they undertake and their location c) How many contractors, their classification, type of work they undertake and their location d) How many are graphic designers? e) How many are media managers? f) How many organise events?

Answer:

a) The department has 66.2 ongoing staff as at 19 November 2013. There are 61.2 ongoing staff located in Canberra plus five interstate based public affairs officers. These staff support the ministerial offices, the departmental executive and business areas on a wide range of communication issues, including media liaison and monitoring, internal and strategic communication, promotion and events management, coordinating external communication campaigns, branding, publications design and production, audio-visual productions, speechwriting and production of the annual report.
