RE: INMATE :- MAURER - ROSEMARY IRENE

DOB :- 25-7-1956

INCARCERATION :- FROM 1961, OVER A PERIOD UNTIL 1974

PREAMBLE :- (1) I RECOMMEND THAT A NATIONAL ENQUIRY BE CALLED INTO THE ABUSE OF CHILDREN IN INSTITUTIONAL CARE (i.e. CHURCHES / GOVERNMENTS) AND THAT THE FEDERAL GOVERNMENT OF AUSTRALIA DEBATE THIS ISSUE AND ACT ON FINDINGS ACCORDINGLY.

(2) I PERSONALLY SEEK MONETARY REMUNERATION AS DUE COMPENSATION FOR THE ABUSE I RECEIVED IN CHURCH RUN ORGANISATIONS AND GOVERNMENT INSTITUTIONS FOR THE PERIOD OF CHILDHOOD THRU INTO ADULTHOOD

BACKGROUND :- MY ABUSE WAS FIRST REALIZED AT AGED (4) YEARS WHEN I HAD THE MISFORTUNE TO BE PLACED IN A CHURCH RUN HOME NAMED "W.R. BLACK" AT CHELSEA QLD. FOLLOWING THIS AWAKENING, I WAS DECLARED AS A CHILD IN "DANGER" AS THE SYSTEM SO QUAINLY STATED, DUE TO THE FACT THAT MY

MOTHER HAD PASSED ON AND I WAS LIVING WITH MY FATHER. TO THIS END I WAS PLUCKED FROM WHAT FAMILY I HAD LEFT AND CATAPULTED BACK INTO THE ABYSS CALLED "CHILDREN IN CARE" FURTHER STINTS IN VARIOUS HOMES (AS CITED IN THE FORDE INQUIRY INTO ABUSE OF CHILDREN IN CARE REPORT QUD - 1999) UNTIL I HAD THE GUTS TO SAY ENOUGH IS ENOUGH. AT AGE 14½ I TOOK CONTROL AWAY FROM THIS EVIL AUTHORITY, GOT A JOB AND WAS ARRANGED HOUSING AND A FUTURE UNDER MY CONTROL.

CHURCH AUTHORITIES :- I WISH TO SUBMIT THAT RELIGIOUS ORPHANAGES FAILED THEIR DUTY OF CARE AND SHOULD BE HELD ACCOUNTABLE FOR THE LACK OF FILES, INFORMATION AND REPORTS ON CHILDREN IN THEIR CARE AND THIS ONE ACTION TOTALLY CONTRAVENES AND IS A DIRECT INFRINGEMENT UNDER THE CHILDREN'S SERVICES ACT AND REGULATIONS (I.E. RECORDS WHICH CHURCH AUTHORITIES WERE BOUND TO KEEP AS LAW UNDER THE ACT)

GOVERNMENT DEPARTMENTS

AND AGENCIES :- THE DEPARTMENT OF GOOD INTENTIONS (ALIAS CHILDREN'S SERVICES) HAVE NUMEROUS FILES, REPORTS AND INFORMATION BUT CHOOSE TO RELEASE ONLY MINOR NON DAMNING PROPAGANDA. THE DEPARTMENTAL FILES HAVE VARIOUS WRONG AND INCORRECT STATEMENTS AND UNDOCUMENTED INCIDENTS.

QUD HEALTH :- THIS DEPARTMENT HAS NO INFORMATION OR FILES (AS THEIR STORY GOES) ON MEDICAL TESTS OR TREATMENTS I RECEIVED IN CARE!

CENTRELINK :- ARE NOT BY NATURE AND TROUBLE SOME FOR MANY ABUSED.

FORDE TRUST :- TO ELEVATE MY SITUATION AND "MOVE ON" I ARRANGED AND FUNDED MY OWN FURTHER EDUCATIONAL PROJECTS. WHEN MY OWN MONIES WERE EXHAUSTED I APPLIED TO THIS TRUST FOR ACCESS TO RESOURCES ONLY TO BE DUMPED HALF WAY THRU THE COURSE. SO NOW I HAVE NOTHING - I AM SO DISTRESSED BY THE PROCESS OF APPLICATION I DON'T FEEL IT IS WORTH LOSING MY MENTAL HEALTH ANY FURTHER SINCE THE PROCESS OF APPLYING, WAITING ETC. IS DISEMPOWERING AND SOUL DESTROYING.

AFTERCARE RESOURCE CENTRE :- AS PER NEXT ABOVE - AS GOOD AS USELESS - REFUSALS ETC. MY OPINION IS THAT THIS AGENCY HAS A HIDDEN AGENDA AND IS TO CLOSELY ALIGNED TO "RELATIONSHIPS AUSTRALIA"

ESTHER CENTRE :- AS PER NEXT ABOVE - REFUSED TO ALLOW US TO SHARE OUR EDUCATION KNOWLEDGE GAINED, SO I HAVE TO USE ADVERTISING IN NEWSLETTERS (E.G. TFF, OLS FOR HEALING, CREATIVE MEMORIES ETC) MY OPINION IS THIS AGENCY IS TO CLOSELY ALIGNED TO THE "CATHOLIC CHURCH."

STATUTE OF LIMITATIONS :- IF YOU COULD DEVELOP A SCENARIO A FACTUAL BASIS TO FIND THAT CHURCH AUTHORITIES / GOVERNMENTS WERE COMPLAISANT, THEN YOU COULD SUE THEM THRU THE COURTS. YOU MIGHT FACE SOME STATUTE OF LIMITATION PROBLEMS WHICH ONE WOULD HAVE TO OVERCOME BY SAYING THAT THE

"DUPLICITY" WITH WHICH CHURCH/GOVERNMENT HAS DEALT WITH THESE ISSUES, SAYING ONE THING FOR THE OFFICIAL RECORDS AND OTHER THINGS IN PRIVATE AND HITHERTO UNRELEASED RECORDS (12 RECORDS WHICH THESE BODIES WERE BOUND TO KEEP BY LAW UNDER THE ACT) THERE IS GROUNDS ON WHICH TO SAY THAT THE STATUTE OF LIMITATIONS WAS TOLD BY THAT KIND OF CONCEALMENT!

SUPPORTING DOCUMENTATION :- COPIES OF DEPT OF CHILDREN'S SERVICES FILES WITH EXTRA NOTATIONS BY MYSELF. UPON PERUSAL PLEASE RETURN AS THE PROCESS OF OBTAINING ANOTHER COPY FROM THE GOVERNMENT IS A DAUNTING PROSPECT.

FOOTNOTE :- ALL REVOLUTIONS ARE IMPOSSIBLE UNTIL THEY HAPPEN. THEN THEY BECOME INEVITABLE. ONE OF THE THINGS THAT HAPPENS HERE IS THAT THIS CHILD ABUSE MOVEMENT HAS ACQUIRED AN AIR OF "INEVITABILITY."
