Sir, Madam - High Court and Family Court of Australia; that matters  
 here related were on 12.12.2003 delivered in person to the Victorian  
 police (Ballarat) and the Courier Newspaper. I urge and trust that you  
 please consider the following statement and its relevance to  
 the family court, foster care in crisis Senate inquiry.

 war, racism and the denial of justice) and a tormented soul

 without delay for justice denied is justice delayed. This one letter

Aboriginal law are central to the fact that if someone knows of a crime committed or planned but remains silent then that silence makes them complicity in the crime.

Ignorance of the law is no excuse, so much of Australia's, home, foreign, forest, land, & nuclear war policy is predicated upon the White Australia Policy as a wise Canberra academic wrote in 1929 - or he said it was an "indispensable condition" of all other Australian Policy, and in the realm of forest clearing policy when myself and Tim became inmates at the Ballarat Orphanage for a combined total of 40 years, (I add that may probably be 146 years - see addition to police report) we were in a special situation as not wards of the state - all mail, parcels, money were vetted through the Ryall Saw mill of Creswick - under what jurisdiction as inmates is not yet determined in who was acting guardians, to the full extent of the law, especially in view of the knowledge now more ~~is~~ available of the workings of that institution (who address was secret only P.O. Box 87 Ballarat - see Vic government social welfare directory)

"Much of history of Australia since 1788 has (been) based upon the removal of children and then the blackmail of children, the blackmail of the land through damming and the blackmail of art but if I am now am aware of atrocities bordering upon murder and that the foundations of Cryall castle are intimately and inexorable linked to the Ballarat Orphanage and our internment there - then I am bound to tell the truth regardless of all consequences.

"I hope that you can find it in your heart to publish this appeal to the gates of heaven so that all correspondence between the Ryall (Saw) Mill and the (Close) family can be subpoenaed and a thorough inquiry can be held. (P.S.) →

In this way, it is then available to the families of the inmates and those inmates at time who were never informed of our unique ~~of~~ situation that made possible for their exposure to unlawful, and dishonest exploitation of the children in the home during the period from 1952 - 1961 and possibly further, it also enables me to write Sorry for the crime of child prostitution and deception of the authorities and community and would better help expose the hidden exploitation of the children and ourselves as children which is so much a part of crisis of the unlawful removal of children from their parents and the need for justice for the stolen generation.

If ~~the~~ as the former Governor General was able to block the legal proceedings of Annie Tarmou and that the AMA (The Australian Medical ~~Education~~ Association) is styming medical reports on the inmates of the Ballarat Orphanage and it seeks to justify this on the grounds of persons not yet deceased then they must see that a ~~children~~ (child) child under 10 who due to operations, drugs or treatment becomes not a child but an adult responsible for murder and can't claim ignorance of the law.

Then it becomes a problem of the entire community, as this can not be deemed an individual story of a particular family especially when beds were (literally) sold for the annual appeals and some of us have tried to say it was it was child prostitution which is foundations of castles & palaces.
