


Rachel Anne Smith  
Born May 22nd. 1950



Taken from Home 1956 with all Bros & Sisters 8  
Made ward of State - spent next 12 yrs. in  
Childrens homes & in "foster case" - "Foster Case"  
was actually being "farmed" out as temporary  
worker -

All most every home was "Christian"  
almost every home I was sexually abused &  
often Barred or underwent severe & horrendous  
punishments - ie whacked across knuckles with  
Barbed wire or locked in Dark Cramped  
places - belittled & made to feel worthless & so

- I ran away from every one of them -  
my reasons for running were never listened too -  
~~I~~ at age 11 I even appealed for help  
from the Newspapers - was printed but not along  
lines of complaint - My earliest years were in  
the Homes & Orphanages of Victoria & my times  
in NSW institutions was mostly whilst on the  
Run from Victoria - The two main Horrors of my

life were Winton Girls Training Centre &  
Parramatta Girls training Centre in NSW - Both  
places were shocking in how I was treated -  
In Winton - after being returned from  
absconding I was locked in the cells wearing  
Only a Singlet & was ignored that I needed to go  
to the toilet - I had to do my business in the  
corner on the floor - when the staff saw this  
I was verbally abused & they stuck the hole in  
thru the outside window & wet me & the cell  
I had to sit on wet concrete all night was angry &  
Made a lot of noise calling out & banging

in my upper inner thigh!

on the door to which I was told if I didn't shut up they would send in the Police psychiatrist

a Dr. John Birrell - about day light the Cell door crashed open & 3 men rushed in on me & I was thrown on my back on the floor & pinned down with a knee across my throat & my legs were kicked apart & I was given a Paraldehyde injection & then carried off to Lakundel psychiatric centre - it took 3 days for the drug to wear off & I had been sexually abused I WAS 11 YEARS OLD!

I escaped Lakundel & when caught was sent to Mont Park Mental Institution - I escaped from there too!

it was during one of the times I was 'on the run' that the police sent me to Parramatta Girls Home & whilst there I was kept locked in Segregation & made to paint the rooms - (locked in with no air flow - I got sick -)

I was locked in the Isolation Cells for bugging in the Dinning room - was locked in what was the Dungeons because my Spots knickers hung below the uniform - The punishments I received were brutal & most for the flimsiest of reasons - I was also sexually abused while locked in the "Dungeon" & when I complained to Staff was sent back to Isolation! I consider that how I was treated in there "Home" to have been an abomination to which I have NEVER recovered - & what with all the rest - I have one thing to say after I read my Welfare file - That is? Being a Ward of the state was a cruel joke And that my 'guardians'

ought be charged with Gross Neglect of their duties  
for I was Never protected & in fact was placed in Danger.  
I am pleased to hear an Inquiry is going on -  
for I have always said -

I Shall die content to  
know these things have been exposed - & that  
I am willing to speak out - That time has come -  
what was done to me in the homes & institutions  
of Victoria & NSW was like something out of  
the Dark Ages - & Always - I was under threat  
of Both Police & Institutions NOT to speak out.  
My Police file on its own is 90% fake for most  
of the time they wrote anything accursed me of  
much - it was like they wrote down anything just  
to lock me up again -

I was outspoken & did not  
take my punishment lightly & was treated worse  
because of it -

for 30 yrs. I have not lived in  
Victoria because of Police threats & never return  
to my home state & NSW Police if I ever spoke up  
said I would "disappear"

I fled to Cape York &  
only the desire to be with family brought me back  
here to NSW & I have lived in fear for all that  
time -

I am still very much afraid & all those years  
of abuse have affected me greatly - I still suffer  
& my family have suffered as well - so much so  
that I can never be a part of Normal Society - I  
am afraid of Doctors & needles - afraid of Welfare  
& terrified of being locked up again - Thank you  
for this enquiry - it's about time the truth came  
all out - it is a great relief to know someone

believes us for what we went thru & I sincerely  
hope in the future - no child is placed in a  
"Good home" Simply because the people are  
"In Christian's" -

For as far as I'm concerned -  
nearly all those "Christians" were pedophiles  
Rapists & Brutal people - men & women alike.  
I state also that not once did I ever feel I was  
with Caring people - had I been - I would have  
had no reason to escape - I was not sent to  
people "for my own good" - I was sent to those  
who needed a Slave & Slave I was - for all  
those years -

This is my complaint & I swear by  
God above that what I say is Only apart of  
the truth -

I apologize that I do not present  
my story in a healer aspect - I do not have  
modern facilities - but by my own hand I write  
my truth -
