



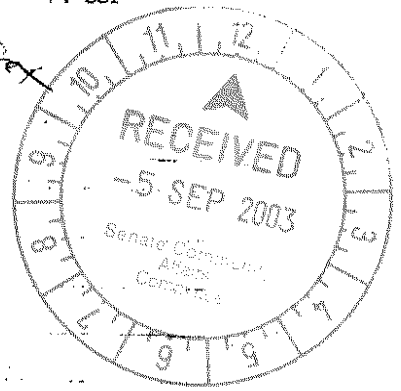

I firstly wish to point out —
for me, you are not ministers
I respect. You are people in power
who have lied to the
Australian Public, and who have caused
great pain and humiliation to good and already suffering
Australian people. I am an Australian —
not afforded the opportunities
both of you have had.
My mother was an Australian Orphan
who met and married
my Jewish father, who was
a tortured man from Warsaw,
Poland.

* The upshot of this letter is that
when I was 6, in 1956,
when my parents were
in depression, grief and poverty,
a Jewish Couple came to our lowly
rented house, with a
solicitor, and took my baby
sister. This horrific kidnapping was
encouraged and supported by the
Jewish Welfare.

I have never recovered from
this trauma.

In fact I have lived my entire

life - in my own country, being forced to cover this crime up. No-body would listen to me. I went on tragically and unbelievably like Holocausts victims, to be abused many times over by both the Jewish Welfare and the State Government.

I have spent many years homeless, lost and abused, in and out of psychiatric hospitals being labelled with a variety of degrading, demoralizing and humiliating "adjectives."

The Jewish Welfare (now Jewish ~~Core~~ ^{or should say Jewish Non-care!}) who is accountable for a lifetime of exploiting me, have never been available in the last near 20 years. When I tried to confront them, with what they have done, or to obtain help.

In fact they have audaciously told me that I have no place contacting them because, in their latest words "I am not really Jewish"

This vicious hypocrisy is stated despite the Jewish Welfare tracking me down in 1969, when I was pregnant, and organising

the abduction of my son; for their rich Jewish friends to adopt. This is — after they knew the state govt took my first son! I cannot cope with much more writing at the moment but things are much worse than I describe here.

I have no advocate to help me write this letter.

And writing all this is very painful. But the short-term reason I am writing is because Centrelink have rejected my daughter Daisy's (my third child who was taken - but I got her back) application to obtain a measly \$87 per fortnight for helping to look after me, as I now suffer from severe POST TRAUMATIC STRESS.

We also live in abject poverty and chaos and confusion.

It is totally cruel and mentally torturous for your offices to make me and my daughter spend fares, and be humiliated, going back and forth to Centrelink and doctors — for more "evidence" that I have POST TRAUMATIC STRESS.

The Centrelink ^{staff} ask cruel questions like what does Daisy do to prove she

is a cause.

But anybody who has a family member in any sort of grief will know that "being there" for a traumatized family member can only be articulated in so many ways.

I cannot believe the cruelty of your departments.

My Uncle died (my mother's brother) on the Kokoda Trail and my ^{late} mother and I have paid our way in blood sweat and tears of 4 children been "swindled" by your welfare departments, - 3 of which were given to lazy fat infertile, selfish cruel heartless thieving rich couples.

Whilst me and my late my mother have lived a life of mongrel dogs!!

Now you are trying to destroy my third child's opportunity to have a roof over her head and stay with her Mum.

Gods knows, if we do not at least obtain this measly \$87, we are in no doubt going to become homeless again!!

And may I state here and now
 - my poor baby sister who I met
 a couple of years ago, tells me
 she was tearously abused, as
 were my two sons,

None of them thank-you for
 "saving them", from me and
 my late mother!

Well "saving them" was the given
 excuse, I have now found out
 about all the cruel selfish "adoptive
 mothers" being infertile, and
 not accepting their lot,

I have been told that some
 of the infertility was because of
 abortions and the pill. I've even been
 told some of the callous "adoptive mothers"
 just didn't want to sleep with
 their husbands or ruin their figures!!

And so me and thousands of poor single
 mothers (although my mother was even
 married), had their lives destroyed
 because of this cold heartless
 callous cruelty of "I want -
what I want - when I want it!"

Real Christian - yes indeed!

Real Jewish ethics - yes indeed!

Well my late Jewish grandparents
 would have been in their
 graves to see me living in a Holocaust
 situation they ran from in Warsaw!!

Focusing once again on the

making-class induced poverty and hell in which we live in. (me and my daughter), I demand that you amend this situation and let my daughter get back to her school-work - so she can try to finish her year 12, instead of spending all her school time singing Centrelink!!

I demand that your offices stop all this abuse of us exploited Australians. I think you are hypocrites on the public purse! Daisy and I are Australians. We should not be living life refugees! This land is my land - it's not owned by you or the Rich Jews!!!

My Uncle - my Australian Ancestor died for his Country

Please respond to this letter urgently Mr Howard as you would if a family member of yours was in trouble. Going by your own christian beliefs I am as good as you.

from the institution.

Mr Howard if this is what the
government has done to an Australian
family - who you claim to be
fighting for, and protecting - then
I cannot imagine the horrific
