How fitting, that you too have no name. As a small child, the distance set between the so-called carers at the "homes" is - lack of names - or terms associated with human care - the real sort.

Matron! Mr! Mrs! All institutionalised + distant. As a child, I'd been, along with 3 younger brothers, tossed between several homes in West Aust. My mother had been in a Catholic Boarding School. So she was a wreck from the start (Abused, violated etc)

Salvation Army home Coltrane - Parkerville - the Methodist and there's others. Govt receiving home. (for passing on the unwanted?) Presbyterians at Byford.

My brothers got to Catholic home too. They're messed up. We have no contact - which hurts me.

Me? now I'm 60. I was abused, bashed, starved, tortured, disregarded as either a child or human. (ie) one instance due bed-wetting due STRESS I was undressed. Naked. Stood on one dining area table so all the children could jeer! I was 8 or 9. (Presbyterian)

Parkerville. Anglican. Children's potties were tipped on me to revile me. I'd fainted doing bath duties on little ones. I'd had an oral proced. that day that required stiches and a Tooth cut out (not pulled). MORE yes there's MORE the bashing, the cruelty, the Grey Pomridge full of weevils. (I volunteered at 9 or 10 for the staff tables & kept their meat-bones to run away + use them to catch yabbies in a tin. etc them RAN

ORDINARY PEOPLE WILL NEVER COMPREHEND.

We ate the pig food too. & the chook mash.  
I tried to have a family. I had LOVELY  
children & but most of them now hate me.  
I have been down the path of self-destruction  
and do not know if I'm recovered\*

I don't drive a car purposefully (due  
my anger) I don't take my anger out  
on others. Foster Homes? Mrs. Lang. Perth

Drunken of old women with a bunch  
of drunken girls. HORRID. HORRID

I'm supposed to be intelligent, I'm  
a top artist - we live yet in fear  
& poverty because of a prejudice  
system in Qld!!! or is it just because

I try to stand up against, drugs,  
Corruption, immorality, etc & paedophiles.

\* in a deleterious society, how does  
one gauge sufficient self-credibility?

If you want details - I can supply.

But you risk re-opening an horrific  
wound, worse than any global earthquake.

No. The wounds never heal. You're always an  
outcast & different. EVEN THE OTHER INMATES  
COULD BE CRUEL & DISGUSTING. OH GOD

avoids problems ie such as I was in

three generations of my families  
have been affected - badly.

My mother, myself, and my Twins, but

children should have knowledge given them (older ones)  
that they can complain to an outside persons willing  
to listen & believe. In the form of a regular visitor  
from a child abuse prevention group, or? to have visits to  
places & listen to the inmates of these soul killing

Institutions kill relationships normally felt in  
decent families. There's no bonds, in fact, farmers  
are nicer to their cows. You can't institutionally  
care, so de-institute - I can't recall staff  
ever being happy with any children -  
playing, etc. from what I've heard & know,  
Prisoners of crime get more attention & pity.

Give each child a personal time, to  
hear what the child likes & do something  
about it. Staff need to be properly trained.  
Mechanical, <sup>improper</sup> people will only lead to terminal  
robots. Staff need to know some children  
will never forget them\* for good or bad,  
they're human; BUT. the foster care system is  
disgrace. So many foster carers are really  
immoral. money-hungry disgusting morons. you  
STAY WITH THEM! THESE IDEAS WOULD

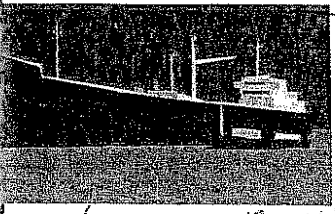
