

## **Child Abuse Crimes Against Humanity Committed By Successive Queensland State Governments.**

As experienced by John Walter McKenna; Jenelle Lee McKenna; Kathryn Ann Garvey; Vanessa Linda Frances McKenna; Joshua Christopher James McKenna (deceased).

Dear Senate,

Please accept this, our submission; to the Senate Community Affairs Reference Committee.

Preamble: Every child has the right to live safely with their own family.

Every family has the right to live safely.

Every person has the right to social justice.

But not here in Queensland.

In the 1960's there was the habit to take a child under the government supposedly assisting wing (there being many veterans of the two world wars requiring social assistance for their families; veterans who gave their youth to protect this country, and veterans who died) and then to call that child a "Ward of the State" and keep the child. Theft, plain and simple.

The message of that day was; stay away from social workers they are all interlocking ratbags and they will steal your children.

As a consequence of the Queensland State Government having ulterior motives of intended cover-up of responsibility for abuses committed by government and as a precursor to introducing harsh child stealing adoption laws; the Queensland State Government introduced the State's populous to an episode called loosely :

"The Leneen Forde Inquiry"

and called punctitiously :

"Inquiry Into The abuse Of children In Queensland Institutions."

Many people did not know it was held until it was over. Many people did not know of it until it was nearly over. But most importantly **none of the government's victims were contacted by the government and given the opportunity to participate in evidence giving. Many of the government's victims were refused when they requested to be able to give evidence.**

Example : John Walter McKenna was a victim in the 60's of abuse in care by the Queensland State Government as was some of John's sisters. Such was the abuse suffered by John he is blessed by God of very little memory of it; but even those few memories are difficult to live with and are kept hidden in the recesses of the mind most of the time.

Memory One : first night in care; busting for pee; has been an all day travel and it is now late. Haven't seen my Mum for ages, where is she? What have they done to her? WHERE'S MY BROTHER AND SISTERS? (I'M CRYING AS I REMEMBER AND WRITE WHICH IS WHY I ONLY NOW NOTICE THESE PRITING MISTAKES AND recover my composure and correct the caps lock but I leave it as is as evidence of deeprooted trauma.) WE were not fed that day except the brekkie Mum had given us. John was not given access to the toilet and did not and does not understand why; but it had something to do with a brainwashing control exercise they employed to make kids know right from the start they are in hell and it will be a bigger hell if the kids don't do only exactly what they are told. Late into that night John repeatedly whimpered and was told to "Shut up sook!" by a big fat woman until around one in the morning John peed himself. All hell broke loose. Two big fats came to John in fetus position head down on the dorm bed, cold, whimpering, frightened, not understanding. And one big fat dragged him out of the bed and across the floor to a babies cot with it's side up and she threw him into it with such anger John wasn't game to move. He was then told if he peed the bed again they'd rub his nose in it.

Memory Two : John was about to eat a piece of fruit being offered by a carer in that orphanage/institution when he was stopped by another one who ordered John to follow her right away. Kids were kept segregated most of the time but this day John's sister Christine had a head

wound and they couldn't calm her down. When John got there on a grassy knoll near an old City Tram with lights removed stood Christine holding the blood in, oozing from a gash in the back of her head. Another child, a boy, had thrust Christine's head into the large round empty light recess of the tram and split her head open. This was the first time John and Christine had seen each other for at least a week, neither saw any other relative, neither heard from or of any other relative. Christine pointed the finger accusingly at the boy who had done it and the carer who could have prevented it. Apparently Christine had been:

"Sniveling too much and that woman told him to shut me up!" John attacked the boy immediately but was pulled off and John was taken back to the now empty fruit plate which means John had no food then till evening mealtime. Another boy said the boy who abused Christine was allowed to do it and that he did it all the time and he'll probably kill Christine. No more memory of it. We never saw each other again until at home.

Memory Three : Sandgate State School I miss my Mum and my family. Sometimes I can see Christine or Gwen way across the paddock of the orphanage/institution, they are way over on the otherside and I am way over here. Why aren't we allowed to see each other? I don't want to go to school I want my Mum and my family. A boy says his dad was a lieutenant in Dad's unit during the war and knows Dad well; this boy says they(the carers) are trying to get us all adopted away and that's why we are not allowed to see each other. I don't like the look of the Sandgate school teacher. (She had short dark hair with thick darkrimmed glasses and looked like a deliberately drawn ugly version of Lois Lane in a Superman Comic I saw years later about Superman in a reverse world.)

John has no more memories of those traumatic times. John spent separate times in : Nudge Orphanage; Woollowin; Sandgate; for no good reason. During the Leneen Forde Inquiry all documents viewed covering the periods John was "in care" would have been apparent to the Department Of Families, Youth and Community Care which actually held and oversaw that Inquiry. During that Inquiry our names were very well known within the Department and the Government; and it is our belief that they saw John's name and address which today is the same home address as way back then. But they did not contact John, instead they covered up. And John fighting then for Jenelle's stolen Kathy had no thoughts of his own traumas; his mind was grappling with the unbelievable reality that Kathy was stolen and being neglected and abused in Queensland Government care.(such is the trauma of those years and the now, that John seriously wonders because he has seen it written or heard it on TV news that Premier Beattie was a ward of the State : (1) has he been so uncaring of the current abuses and so allowing of the abuses his government does to us because they know something about his "in care" years which enables him to be controlled by them? Or (ii) was he the son of Dad's army mate? Or (iii) Was he the boy ordered to abuse Christine by thrusting her head into the Tram's empty light fitting?

Example : Jenelle Lee McKenna previously Jenelle Lee Smith. We don't know which to blame initially but either the Queensland State Government or the Australian Government in 1966 controlled the fate and the various government services of New Guinea. Medical services even at Goroka hospital were primitive. Jenelle was breach born. Umbilical cord around Jenelle's neck, Jenelle's mother laboured for fifteen hours while for a significant part of that labour, the doctor carried on playing golf. Jenelle says there were 37 children born handicaped around the same time as she. Jenelle was born 10/8/1966 Goroka Hospital. When Jenelle was fifteen efforts were made to sterilise her.

Jenelle went to school at the Redlands Special School and she was abused at that school repeatedly. Complaints went to deaf ears and even resulted in threats to her and to her mother. During the Leneen Forde Inquiry; Jenelle asked if she can give evidence and was refused because though she was abused in a Queensland Institution, she was living at home at the time.

Jenelle's first daughter; Kathryn Ann Garvey was born 17/7/1995 in the Mater Children's Hospital. Plans were made some five months before to steal Jenelle's baby and give her away in an adoption. The person they were going to adopt Kathy to was someone who they'd been unlawfully giving kids for years; a woman by their own standards who was : too fat; too old; too ill. And that woman had an already far too crowded house; crowded with genuine parental sex-abuse victims and some with ADD through drug ingestion by their mothers during gestation which

made it a real hell hole for a little girl to go to. First time John saw that woman she presented as a woman with Jenelle's baby like a pet monkey with the added bonus of bringing that woman big bucks, and she wasn't actually looking after Kathy, others did all the work. Kathy even before the Leneeen Forde Inquiry was neglected and abused "in care". Jenelle tried to give evidence at the Leneeen Forde Inquiry of the neglect and abuse of Kathy but Jenelle was refused on the grounds that the Inquiry Into The Abuse Of Children In Queensland Institutions did not cover children abused in "Fostercare". Yet the State Government and the media pretended at the time that it was the Holy grail of Inquiries and it ventured into everything. Scandalous. Significantly at the same time throughout the community people were trying to be heard; people who were victims of sexual abuse in State Schools and in religious Schools. Again those were refused as the Inquiry was not allowed to delve into such areas. Significantly MP Bill D'Arcy and the State government at that time had a lot to conceal and did. Indeed only a couple of years beforehand Wayne Goss had unlawfully shredded the Heinen Report. Kathy is still being abused in care today. Jenelle is not allowed to see or talk to Kathy.(Same process used in the sixties.) None of us are allowed to see or talk to Kathy.

**NOW ; you may think the above sufference is bad enough for civilised people to endure but we assure you it is not the half of it.**

To achieve their evil ends the various government departments responsible for the evils perpetrated tell malicious lies and concoct false and malicious histories of their victims. They use the children in medical experiments and some of the staff abuse and have sex with children "in care". Control is such that kids know when to keep their mouths shut, or else. There is no genuine humanity, no genuine religious intervention based care. Indeed unlawfully the government denies parents the right to have their stolen children baptised. Kathy is not baptised even though both father and mother requested baptism in writing. Similarly [redacted] were refused when for seven years they requested that their stolen son Mathew be baptised. [redacted], a handicapped woman, was assaulted in a toilet by a Vallety FSO. The Dept and the Premier ignored our complaints of this. Their telephone number was [redacted]. They do not know we name them here. So traumatic is the dealings of this government with families whose children they steal that no news is good news and the burden of each others pain is too gross for any but God to bear so, to our shame, we have not maintained contact but they are in our thoughts always. So evil are those of this government that they tried to stop the wedding of John and Jenelle. In the case of the Micallef's they tried to split them apart even though married and thankfully failed to steal their children.

Not only do they strive to undermine families; they strive to destroy support structures. They deliberately even today, keep false and malicious records and as often as they can they drum up fake notifications to enable them to con the most decent of magistrates.

Because we made them aware we are making submission to the Senate, FSO's at Redlands and Mount Gravatt drummed up false notifications and strive to steal Vanessa, Jenelle's second, and John's first child. Given that efforts were made to sterilise Jenelle, Kathy's birth and Vanessa's birth are proof to us that children are a gift to their parents by God.

### **Recommendation:**

In some American States rapists are desensitised to counter recidivism. Rapists with electrodes attached to genitals to detect sexual stimulation are shown sexually stimulating material and when they become aroused an electric shock is passed into the seat of their pants. Progressively, many become far less likely to rape than otherwise.

From this comes detection possibilities. We earnestly believe all Child

Safety and Family Services Officers and Carers who have any contact with children at all should be sat in front of that sad accumulation of child porn material the government possess and if arousal is detected through the electrodes those staff should be denied access to Blue Cards, access to children, possibly they should even be sterilised.

The government departments which are supposed to keep evils such as we have experienced from happening seem to be part of it.

CJC did nothing for anyone.

CMC did nothing for anyone but held a pretend Inquiry in which they claimed our evidence was not evidence even though most of it is the stuff the dept puts to magistrates as "evidence". Which is why it is not included here but any time you want us to email it to you or verbally recount it please tell us.

Police are stopped from helping by "orders from above" meaning the Commissioner's Office and from the government.

Coroner's Office doesn't reply to concerns about deaths in care.

Ombudsman is always port of last call and always unable to help.

Politicians who are independant are warned off by the Premier or so said staff of Peter Wellington MP. And communications with Dorothy R Pratt MP seem to confirm that situation as she promised once to put our case before the parliament in questiontime but when we told her what Peter Wellington MP's staff had told us about them being warned off by the Premier Dorothy seems to have gone cold on the idea.

We do not want to be denied the right to make this submission.  
We do not want to be denied the right to give verbal evidence under oath. The CMC concocted an Inquiry of lies and allowed lies to be told by DG's and Ministers and even the Chair of the Children's Commission. Please before God, we beg you to accept this our submission. We want our submission to be public as our religious beliefs do not allow concealment indeed we believe we should :  
"SHOUT IT FROM THE ROOFTOPS".
