Amendment agreed to (division) and motion, as amended, agreed to 12/4/89

### **Australian waterfront**

- The need for immediate action by the Government to introduce reforms which will ensure that the Australian waterfront becomes efficient and productive instead of being a national burden and impediment to internationally competitive economic activities. Moved (Senator Alston) and agreed to 10/4/89.

- The need for the Government to ensure a flexible and efficient working environment on the Australian waterfront through lasting and genuine reforms, including the introduction of full enterprise employment, appropriate changes in union coverage and the elimination of restrictive work practices. Defence - The urgent need for Government action to strengthen Australia's Defence capability by enhancing the capacity of the reserve forces. Moved (Senator Peter Baume) and agreed to 8/6/89n

Economy - The need for immediate action to address the fundamental lack of competitiveness which underlies Australia's balance of payments and debt crisis. Moved (Senator Stoneman) and negatived (division) 24/5/89.

Failure of Government's economic policies - The suffering of Australian families because of the Government's high taxes and the failure of its economic policies evident in soaring interest rates, rising inflation, the balance of payments crisis and massive and still rising foreign debt and the need for a Mini Budget to address these issues and lay the basis for a more productive society in which effort and enterprise is rewarded. Moved (Senator Chaney) and agreed to (division) 1/3/89.

Home ownership - The need for the Government to change its policies which are depriving increasing numbers of young Australians of the opportunity to own their homes. Moved (Senator Boswell) and agreed to (division) 3/3/89.

Industrial relations - The need for the Government to accelerate the pace of reform to achieve a genuine workplace-based industrial relations system which will allow Australians to work together more productively to reduce our foreign debt and to stop the slide in living standards. Moved (Senator Chaney) Senator McLean, at the request of Senator Haines, moved an amendment to the motion:

Leave out 'workplace-based industrial relations system', insert 'co-operative management/worker industrial relations system'.

Amendment agreed to and motion, as amended, agreed to 22/11/89.

Microeconomic reform - The need for the government to reform areas such as the waterfront, telecommunications, transport, coastal shipping and industrial relations because, as the Governor of the Reserve Bank has said, microeconomic reform has a major role to play in raising productivity and is now urgently needed. Moved (Senator Lewis) and agreed to (division) 5/4/89.

Pilots' dispute - In the interests of an early end to the devastating pilots' dispute, the need for the Government to instruct Australian Airlines to open discussions with the Australian Federation of Air Pilots to test the sincerity of the AFAP's claimed willingness to negotiate on pay, productivity, hours and conditions.
