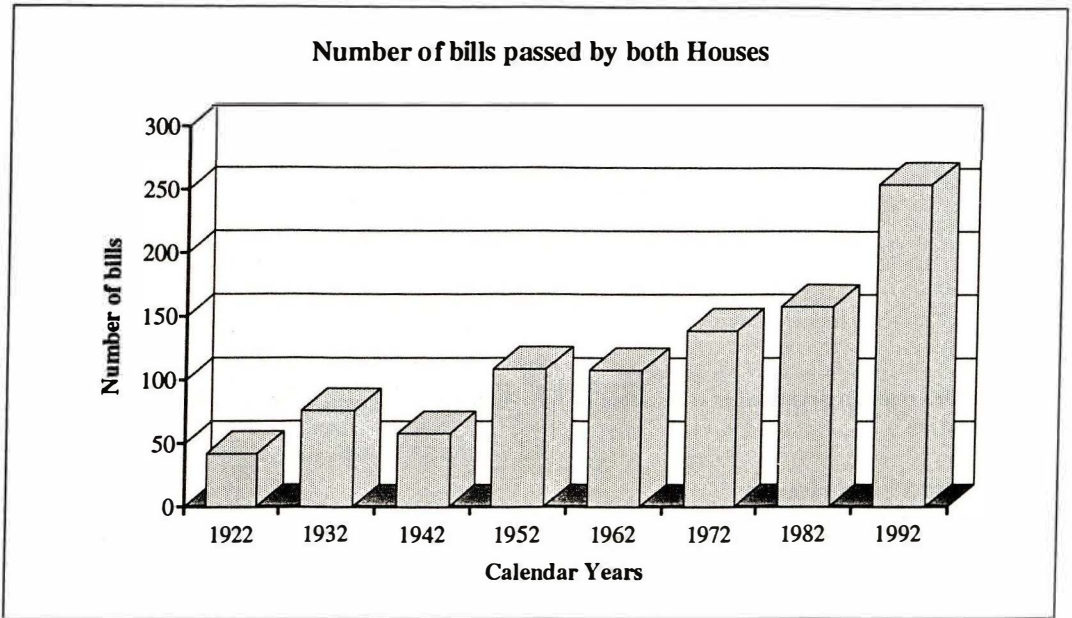

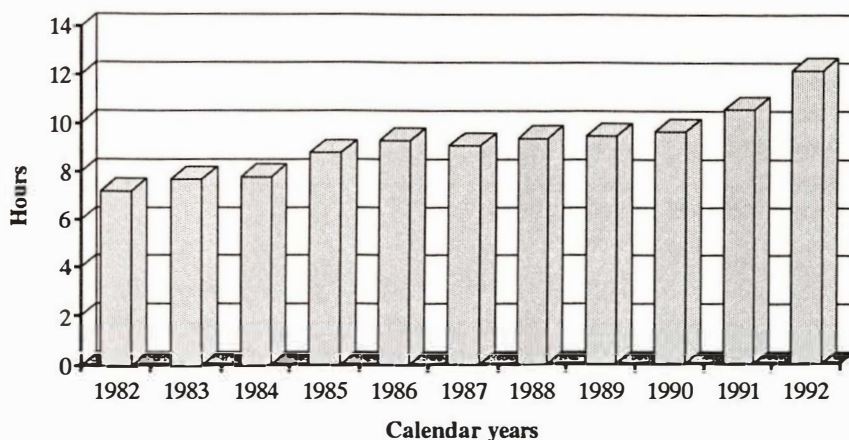

Average length of sitting day in the Senate 1982 - 1992

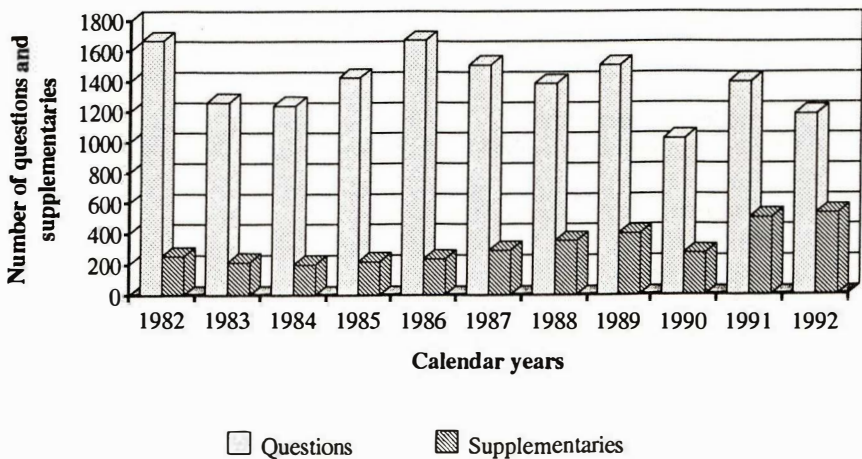

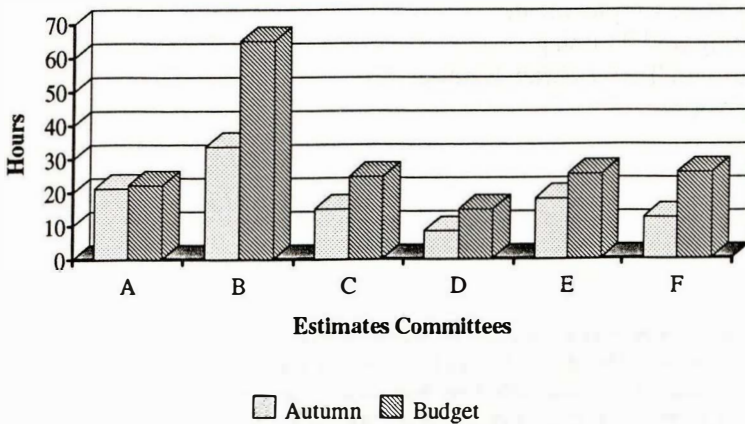
