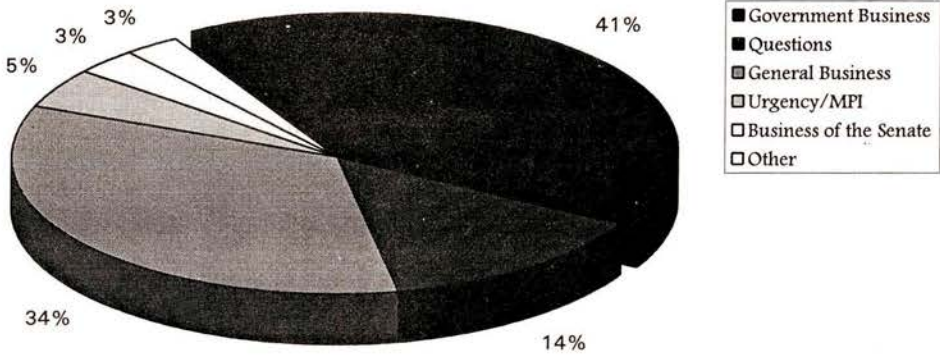

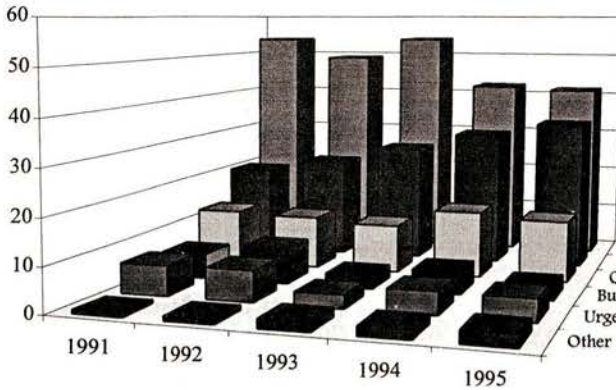
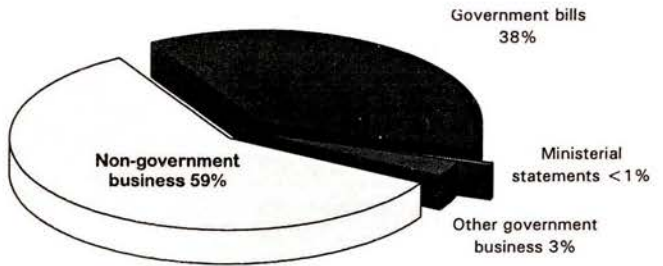

Business conducted in the Senate 1995



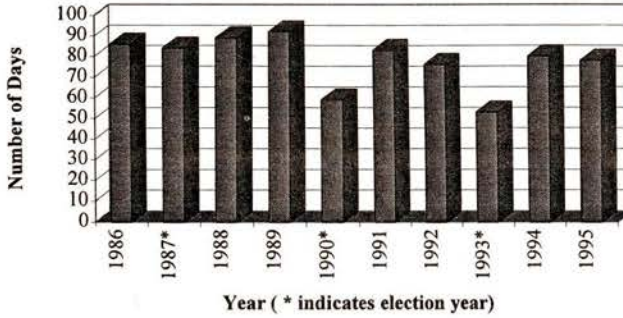
Breakdown of government business 1995



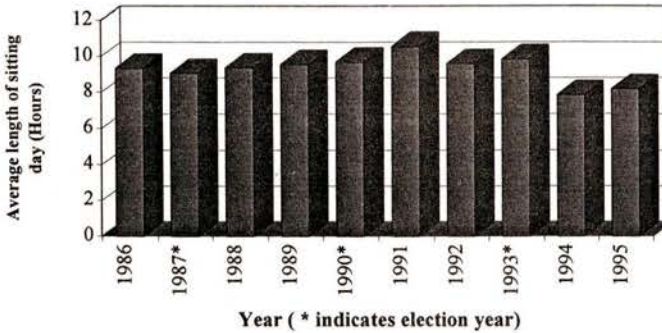
Proportion of time spent according to type of business 1991-1995

Days and Hours of Business

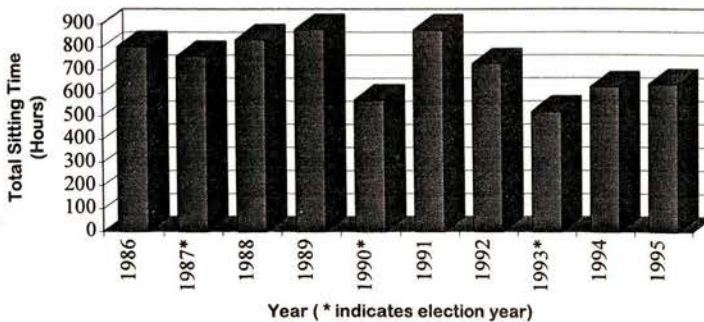
Number of Sitting Days 1986 - 1995

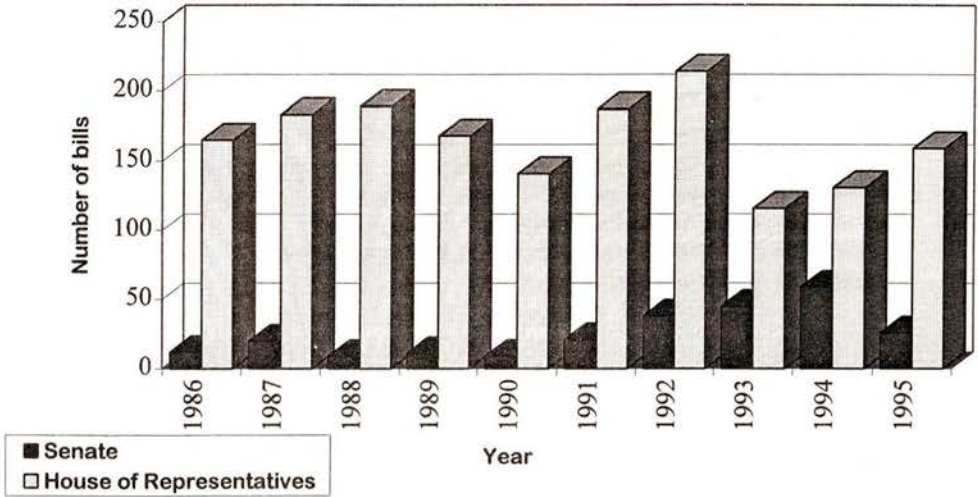

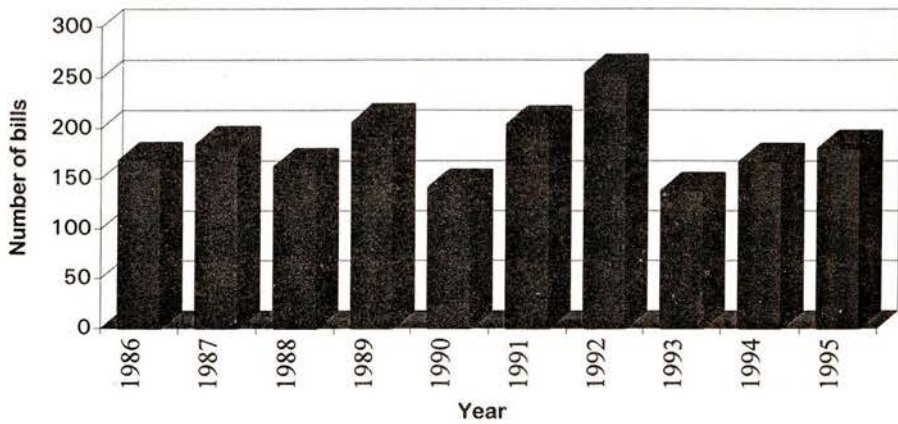

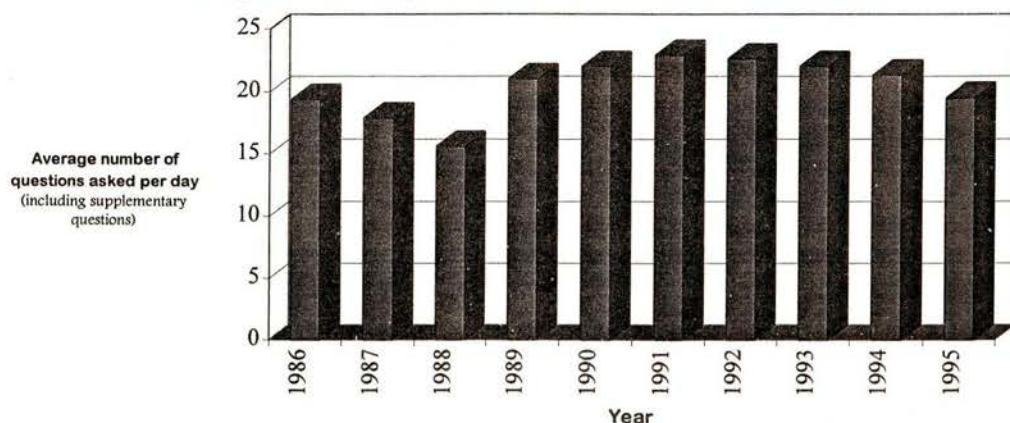
