Re: **Regional Partnership Program Funding**

McCallum provides services to over 250 people with disabilities in Ballarat and district. These people predominately have intellectual disabilities.

McCallum Industries is the business service arm of McCallum and employees 100 supported employees in a factory located at 1820 Sturt Street, Ballarat.

With the advent of the Commonwealth Government QA Reforms which incorporated the payment of an award based wages to supported employees some years ago McCallum Industries has been focusing on the development of the business on a commercial footing to ensure that it would remain financially viable.

McCallum with the support of the State Department of Planning and Development and Commonwealth Department of Family, Housing, Community Services and Indigenous Affairs is in the midst of launching a new confectionery business known as "Ollie's Lollies" in mid August, 2008. A pilot confectionery business has operated since October, 2007. When formulating plans to move into a new business in addition to what McCallum Industries currently undertakes it was evident that the factory would need to be expanded. The McCallum Board from its own funds purchased three industrial blocks at the rear of the existing building at a cost of \$266,000 plus GST.

Prior to the purchase of the land discussions had commenced with vicCHACC about the possibility of obtaining \$300,000 under the Regional Partnerships Funding Program to enable a new factory to be built. McCallum indicated that it would contribute \$300,000 from its own funds. McCallum was in the process of completing a funding application when news was received that Regional Partnership Program Funding would cease.
