### Re: "Inquiry into a new regional development funding program"

Your letter dated the 23 May 2008 highlighted four areas of terms of reference that you were seeking advice and information from relevant organisations to assist with the inquiry.

The Hunter Economic Development Board (HEDC) is the peak advisory body to the NSW State Government on matters of economic development. There are thirteen NSW State Boards in total.

HEDC facilitates the delivery of economic development strategies for the region, markets the region for investment.

The HEDC works in collaboration with three levels of government and major stakeholders to encourage economic development in local Hunter communities.

The HEDC's activities include:

- Promote regional economic development initiatives in the Hunter Region through community co-operation, competitive marketing of the region and hosting Commonwealth and State initiatives;
- Advise the NSW Government and the Department of State and Regional Development on important regional economic development issues;
- Involve key stakeholders, including local councils, in regional development;
- Advance the development of local leadership;
- Support major investment projects: and
- Promote key initiatives to improve the Region's attraction to business investment, including infrastructure development.

The Hunter Vision 20 year strategy aims to provide direction in growing the regional economy, to improve the flow of human and financial resources into and within the region, for the benefit of the community, and to identify actions required to address priorities and challenges with respect to economic development.

#### Inquiry into a new regional development funding program

#### Matter: Consistent Geographical boundaries

**Comment:** Consideration of consistency of geographical boundaries in line with the NSW State Government Economic Development body which includes Paterson and Great Lakes for the new program to assist regional engagement and regional development.

#### > Matter: Funding criteria and models

**Comment:** The new program needs to address the funding requirements of small local communities needs to large scale urban community funding requirements.

The small grants requirements could be quite specific with clear guidelines that could be easily administered and assessed to streamline the process. Dollar for dollar matching funds is a struggle for small non profit organisations.

Bigger ticket items should have strict guidelines with a clear and transparent description of the assessment and the approval process. Regional stakeholders and the NSW State Board (HEDC) could be required to assess and or endorse projects providing a level of protection for the Federal Government to ensure the projects were consistent with state government state plans and local government strategic plans.

The previous Regional Partnership program had very broad guidelines and the Federal Government did not receive the due recognition for funded projects as mostly projects were often a one of. There may be an opportunity to consider Regional themed projects that meet similar objectives and would benefit the Region to gain a strong recognition for the new program for example Health, Sporting facilities, environment, innovation.

Consideration should be given to the private sector on how they could benefit from the new program, private investment is the driving force for regions to grow and retain and expand skills and local businesses and industries.

#### > Matter: Regional Development Partnerships

**Comment:** The HEDC delivers advice on regional issues and opportunities plus facilitates economic development planning and investment. This makes the HEDC a perfect partner to work with the new Regional Development Australia boards to ensure a cohesive and non duplicate approach to see that local priorities are met. For example the HEDC recently managed the 2008 Hunter Means Innovation Festival where local government, major stakeholders, the previous ACC board and AusIndustry joined as funding partners with the NSW Government to deliver this regional opportunity. There were 47 events over a two week period with 2,300 attendees.

## Summary

A new regional grants program needs to be flexible enough for small projects and structured enough for bigger ticket items. A one stop approach in not appropriate for Regional Australia.

Key points for consideration in the development of the program are as follows:

- Clear guidelines supported with definitions and support documents,
- Clear aims and objectives that reinforce that the program is primarily a program that is for the benefit of the region,
  - Streamlined and transparent assessment processes within a specified process,
  - External advice from regional organisations
  - Not to duplicate already existing roles of the State Boards in particular on economic development.
